House panel directed to review PhilHealth charter to enhance benefits The House Committee on Health will conduct a thorough review of the Philippine Health Insurance Corporation (PhilHealth) charter to expand patients' benefits

Speaker Martin Romualdez on Tuesday directed the review that specifically targets an increase in benefits, including coverage of at least 50 percent of the cost in private hospital wards and free examinations for the early detection of deadly diseases, such as cancer.

Early cancer detection measures would include critical diagnostic exams like Xrays for lung cancer, mammography for breast cancer, and the human papillomavirus vaccine to prevent cervical cancer, among



others. statement, In а Romualdez said there is a need for PhilHealth to function as a health maintenance organization, focusing its resources on safeguarding the health of the populace rather than investing in commercial banks and bonds.

CALAX Silang (Aguinaldo) Interchange Toll Collection Starts Feb 10, 2024 CAL

(CALAX), announces the implementation of toll rates for the Silang (Aguinaldo) Interchange, as approved by the Toll Regulatory Board. These rates will be effective starting 12:01 AM on February 10, 2024.



The implementation of these toll rates aids in the continuous maintenance and enhancement of our toll road while ensuring efficient and safe travel for our users. The Silang (Aguinaldo) Interchange has become a vital part of our network, significantly enhancing the connectivity and economic landscape of the region," said Mr. Raul L. Ignacio, President and General Manager of MPCALA Holdings Inc.

Silang The (Aquinaldo) Interchange, a critical section of CALAX, connects directly to Aquinaldo Highway, facilitating smoother and faster travel to key

tourism destination areas in Cavite, including Tagaytay and Silang. It was opened to motorists last November 8 with a free toll until further notice. CALAX has surpassed its targeted daily traffic for the recently inaugurated subsection, with an impressive daily count of 12,000 vehicles—well beyond the projected 5,000 cars and has become an essential component of the region's infrastructure.

11th Asian Age Group tourney to serve as Paris Olympic qualifier

The 11th Asian Age Group Championships (AAGC) scheduled to be held at the New Clark City Aquatics Center in Capas, Tarlac from Feb. 26 to March 9 will serve as qualifier for the Paris Olympics.

Buhain, made the announcement during the Philippine Sportswriters Association (PSA) Forum at the Philippine Sports Commission (PSC) conference hall inside the **Rizal Memorial Sports** Complex on Tuesday.

About 1,300 athletes from 31 countries are expected to join the tournament, which features four disciplines: swimming (Feb. 26-29), diving (Feb. 26-March 1), artistic swimming (March 2-6), and water polo (March 3-9)

Competitions are in the 12-14, 15-17, and 18-andabove age categories.

Buhain clarified though that only the swimming event is the Olympic qualifier.

"World-class swimmers will be coming over and do their best to make the qualifying times for Paris. It's a big opportunity for us to host and see these swimmers. It is rare that we see this caliber of athletes in the field of aquatics coming to our country," said Buhain, a former chairman of the Games and Amusements Board (GAB) and the PSC. The organizers see a

possible surge in the number of entries and countries participating leading to the event after the decision to make the

The AAGC organizers, led by Philippine Aquatics, Inc. secretary general Rep. Eric

event an Olympic qualifier. "It can even swell because now, there are still people chasing to be included in our event,' Alcazar said.

India, Pakistan, Malaysia, Japan, Vietnam, and Sri Lanka have a big delegation. The Philippines will be represented by 44 athletes - 22 boys and 22 girls – who were selected based on the World Aquatics qualifying points during the national tryouts at the Teofilo Yldefonso swimming pool inside the **Rizal Memorial Sports** Complex in October last year.

Four men and women are entered in diving while foreign-based two Filipinos will compete in artistic swimming.

Aquatics World president Husain Al-Musallam and other officials of Asia Aquatics have signified their intentions to visit and watch the event. (PNA)

NEWS Wetlands get spotlight in southern Metro Manila museum Did you know there's a type of land that acts like a giant sponge, naturally soaking up pollutants

and filtering our water? These unsung heroes are called wetlands, precious ecosystems often undervalued despite their critical role in protecting our environment and ourselves.

Almost 87 percent of wetlands have vanished in the past 300 years due to human activities, according to the World Wide Fund for Nature (WWF). Yet, hope remains! The Philippines boasts of 342 protected wetlands, and now, one gets a well-deserved spotlight with the opening of the country's first wetland museum in Las Piñas-Parañaque Wetland Park (LPPWP) in Metro Manila.

This exciting initiative underscores the importance of recognizing these ecosystems and safeguarding them for future generations. Let's explore why wetlands deserve our appreciation and what we can do to ensure their survival.

Out of the 342, Metro Manila has five (5) important wetland areas, namely:

The Tagalag Fishing Village - small fishing village that is home to several species of waterbirds in Valenzuela City;

La Mesa Watershed - a natural basin and water reservation area in Quezon City, it drains parts of Caloocan City, Quezon City, Bulacan and Rizal Province:

Tanza Marine Tree Park - mangrove enrichment area located in Navotas City, home to almost 12,000 bird species;

Laguna de Bay - largest freshwater lake in the country and third largest in the Southeast Asian Region. The cities of Taguig and Muntinlupa share its ecosystem with other areas in Luzon; and

The Las Piñas-Parañaque Wetland Park (LPPWP) - a protected area shared by both cities that consists of a beach, mangrove forest. mudflats, salt marshes, ponds, and lagoons.

What are wetlands?

RAMSAR The Convention, an intergovernmental treaty that recognizes the importance of wetlands defines it as "areas of marsh, fen, peatland, or water, either natural or artificial, permanent or temporary, that are covered with water, either static or flowing." To put it simply, wetlands are lands covered with water.







SM Prime has entered a joint venture with GUUN Co. Ltd (GUUN), with SM Prime holding 70% of the equity of the Philippine joint venture company.
