Rage to the Dying Coal Industry: Meralco's push for coal in Quezon and Cebu is a financial suicide, will further burden electric consumers Fossil fuel giants trying to pull the coal industry away from the death's door is such a waste of

Fossil fuel giants trying to pull the coal industry away from the death's door is such a waste of time, effort, and resources. With the Meralco PowerGen Corp. (MGen) crowing about spending at least \$2 billion to develop coal-fired power plant expansion projects in Atimonan, Quezon and Toledo, Cebu, climate justice groups and communities affected by fossil fuel projects will not waver in campaigning against these dirty sources of energy; as coal must be left to die.

Local banks are moving away from coal. Philippine banks are publicly announcing their commitments to stop financing green?eld coal projects, according to recent reports. Although the government is trying to make fossil gas happen, we are placing equal attention to coal as we look forward to it breathing its last.

while MGen said that the existing 82-MW coal-fired power plant under Toledo Power Corp. had previously secured permits to construct two units, it is very much worth noting that it is included in the dirty projects that made Compliance Advisor Ombudsman declare an investigation to World Bank's International Finance Corporation

(IFC) for indirectly funding fossil fuel projects. This is CAO's response to Philippine Movement for Climate Justice's complaint against the IFC as fossil fuel projects continue to endanger our communities' lives and livelihood.

Resurrecting the coal industry can't be done as communities fiercely fight against it, despite harassments and hardships. Toledo September, residents voiced out their opposition to Aboitiz Power's subsidiary Therma Visayas, Inc.'s coal plant expansion via a petition, urging the company to comply with the law by conducting health impact assessments as their community's health is on the line.

While MGen is saying that the proposed coal plant expansion is included in the committed list, it is proved to have violations done during the permitting and construction process.

PMCJ argued that when MGen was planning to construct the expansion, through its subsidiary Atimonan One Energy (AOE) Inc., in 2021, the Department of Energy had already implemented a coal ban late in 2020. The coal ban bars the processing of new applications for greenfield coal facilities, such as AOE's.

Moreover, AOE's proposed coal project's permit is already abandoned since MGen

planned to build it as a fossil gas facility last 2023. These fossil fuel giants exhaust ways, even going back-and-forth, switching coal to fossil gas, and back to coal, just to push for their dirty projects, at the expense of people's welfare and the environment.

We condemn these pushes for debt-creating, planet-killing, and diseasecausing projects as communities organizations have been laying-out comprehensive plans for the just transition to clean energy. DOST, which is to strengthen research and development (R&D) for environmental preservation and conservation.

"We believe that strengthening initiatives on sustainability, with central importance on the environment and natural resources, will cut across the other pillars – stimulating wealth creation, reinforcing wealth protection, and ultimately promoting human well-being," he said.

The DOST chief noted how investments in Science, Technology, and Innovation (STI) play a pivotal role in fulfilling the government's collective aspiration for a stable, comfortable, and secure future through the values of "Matatag, Maginhawa, and Panatag."

Solidum shared that a "Matatag," or powerful, society is one where families thrive, communities are resilient, and trust in governance is strong.

He said that through the DOST's Community Empowerment through Science and Technology (CEST) program, STI interventions are able to uplift the marginalized sectors.

He cited as example Barangay Bagong Silangan in Quezon City, where 29,070 households have been empowered through livelihood trainings, urban agriculture, and modern technologies, transforming it into a model of economic and social resilience.

Barangang Bagong Silang is just one of over 1,900 communities impacted by CEST, with more than ?1.8 billion invested in science and technology solutions.

In just the first half of 2024, the program has reached 892 more communities and created 913 new jobs, with much more progress on the horizon.

Solidum said that every Filipino deserves a life free from poverty, and DOST's Small Enterprise Technology Upgrading Program (SEIUF) turning this vision into reality by supporting over 9,000 MSMEs; creating 316,000 jobs; and injecting P8.7 billion into the economy. Businesses like AJIS Dive and Aqua Sports Inc. in Cagayan de Oro have thrived with access to advanced manufacturing technologies through SETUP.

To sustain this progress, he said the DOST is also investing ?9 billion in scholarships for 61,237 students in the academic year 2024-2025, ensuring a future driven by Filipino scientists, engineers, and innovators.

Meanwhile, in a country highly vulnerable to naturál hazards, Solidum said ensuring that every Filipino feels "panatag" secure and protected from disasters — is a top priority. The DOST, through the Philippine Atmospheric, Geophysical, Astronomical Services Administration (PAGASA) and the Philippine Institute of Volcanology and Seismology (Phivolcs), plays a crucial role in safeguarding communities cutting-edge with technologies.

"From state-of-the-art Doppler radars and seismic stations to the innovative GeoRisk Philippines app, these tools provide real-time data that enhance disaster preparedness, mitigate risks, and save lives," he said

Solidum also outlined eight major R&D programs for 2025 to address critical challenges in a volatile, uncertain, complex, and ambiguous (VUCA) world. These initiatives include the AI Virtual Hub, Geospatial Analytics Solutions, Quantum Computing, Industry 4.0, Circular Economy, Smart Agriculture, Smart Technologies, and Biologics in Pharma.

"With continued support from national and local governments, DOST is committed implementing bold, inclusive, and practical solutions, emphasizing the urgency of abandoning "business as usual' approaches. Projections based on empirical data warn of a potential global system collapse by 2050 if transformative actions are not taken immediately, " said Solidum.

Maridon O. Sahagun, DOST Undersecretary for Scientific and Technical Services and chair of the 2024 NSTW-Steering Committee, underscored the cutting-edge technologies and S&T products set to take center stage during the five-day celebration.

Sahagun discussed the Human Well-Being Technologies initiative, which addresses critical challenges in health, education, and accessibility through groundbreaking

innovations such as ImGTS for dementia care, i-SULAT for early childhood assessment, ENSAYO for empowering visually impaired individuals, and nutrition-focused solutions like the Enhanced Nutribun.

She also emphasized Wealth Creation Technologies, which seek to boost industries and livelihoods through initiatives like AMCen for advanced 3D printing, sustainable Silk and Natural Dyes Hubs, SAFEWATRS for mobile water purification, and commercialization programs like GALING and . TEČHNiCOM that support Filipino innovators.

Such technologies enhance disaster resilience with tools like I m p a c t - B a s e d Forecasting, SatREx, and Al-powered systems such as SkAI-Pinas, while education-focused projects like REIINN bridge digital divides to strengthen community preparedness.

Lastly, sustainability efforts led by the DOST-Philippine Council for Agriculture, Aquatic, and Resources Natural Research Development include innovative solutions such as the Remote Online Surveillance for Banana (ROSANNA) app for disease banana monitoring, ACTICon biopesticide sustainable pest control, and the eco-friendly Pest to Feed technology, complemented biodiversity education tools for environmental stewardship.

These initiatives collectively underscore DOST's unwavering commitment to improving quality of life, advancing industries, safeguarding communities, and fostering sustainable development, Sahagun said.

In a speech, Cagayan de Oro Vice Mayor Jocelyn "Bebot" B. Rodriguez said: "We believe that Science, Technology, Innovation are essential tools for building a stronger, more prosperous, and secure future for all Cagayanons. We are proud to work hand-in-hand with the DOST. These initiatives stand as a testament to our shared commitment to progress through Science, Technology, Innovation."

Misamis Oriental Gov. Peter M. Unabia, for his part, said STI prioritizes the needs of the most vulnerable. "In Misamis Oriental, we commit to maximizing our resources and collaborating with national agencies such as the Department of Trade and Industry, Department of Labor and Employment

, Department of Agriculture, Department of Health, and Department of Social Welfare and Development to address these needs," he said.

"We express our full support for the programs, projects, and activities of the Department of Science and Technology (DOST). Secretary Renato U. Solidum, rest assured of our unwavering commitment to advancing

STI for the benefit of all," he added.

The NSTW is set to draw over 10,000 attendees, including local government units, startups, enterprises, legislators, and students, among others. The event will feature more than 33 forums at the Luxe Hotel and nearby venues, covering diverse topics in science and technology.

Interactive exhibits include the NuLab: STEM in Motion, offering students hands-on experiences in a mobile laboratory, alongside the

Mobile Modular Food Processing Facility and the Mobile Command and Control Vehicle. A grand expo at Limketkai Center's Atrium and East Concourse will showcase over 150 innovations, including immersive platforms, 3D prototypes, robotics, and sound domes, introducing cutting-edge technologies to the region.

Additional highlights include Scholars and Startup Pitching competitions at Cinema 4, providing a platform for emerging innovators.

"Through these efforts, we aim to build a more resilient 'Bagong Pilipinas,' one where every Filipino consumer is empowered to make informed choices and have full confidence in the quality of their purchases," the trade chief

added.
The DTI-Bureau of Philippine Standards (BPS) witnessed the destruction 13,000 pieces of substandard re-rolled steel bars.

These bars failed to meet the minimum technical requirements set out in Philippine National Standards (PNS) 211:2002, which governs re-rolled steel bars used in concrete reinforcement.

Among the destroyed bars were 5,000 pieces of Grade 170 – 6 mm and 8,000 pieces of Grade 170 – 7 mm substandard rerolled bars.

These were reduced to random lengths of less than 6 meters using

hydraulic and oxy-fuel cutters and will be reprocessed as scrap.

With this destruction, Secretary Roque declared, "We will not tolerate those who compromise the safety and well-being of our citizens for profit."

"This firm action against substandard steel products underscores our resolve to protect lives and foster a business environment that prioritizes consumer welfare and responsible manufacturing across the country," the DTI chief expressed.

Furthermore, Fair Trade Group (FTG) Supervising Head and Assistant Secretary Agaton Teodoro O. Uvero encouraged consumers to be vigilant and prioritize the durability of materials when purchasing products, especially for their homes.

"To strengthen our efforts in ensuring the

safety and durability of Filipino homes, we urge consumers to always look for the ICC sticker or PS mark when purchasing products for those products regulated by DTI-BPS," said Assistant Secretary Uvero.

The activity was spearheaded by DTI-BPS, which serves as the National Standards Body of the Philippines, established on 20 June 1964 through Republic Act 4109, also known as the Standards Law.

With a mandate to develop, promulgate, and implement standards, the DTI-BPS promotes standardization activities and ensures the manufacture, production, and distribution of quality products.

HIV Advocacy Policy Writeshop: Strengthening the Fight Against HIV in Cavite

In a concerted effort to strengthen the prevention, control, and treatment of HIV, AIDS, and sexually transmitted infections (STIs) in Cavite, the Office of the Provincial Health Officer (OPHO), in collaboration with Pilipinas Shell Foundation, Inc. and Initiatives for Dialogue and Empowerment Through Alternative Legal Services (IDEALS) Inc., spearheaded the HIV Advocacy Local Policy Dialogue and Ordinance Writeshop on November 21-22, 2024 at the Cavite Collaboration Center for Public Health, GEAMH Compound in Trece Martires City.

The two-day writeshop gathered doctors and nurses from city and municipal health offices of the province, along with members of the Cavite Province Multi-sectoral STI, HIV, AIDS Council (CPAC). The primary objective was to identify practical action points and collaboration areas in finalizing and advocating for the enactment of proposed local legislation for HIV, AIDS and STI prevention, control and treatment.

The write shop commenced with a presentation on the HIV situation in Cavite delivered by Ms. Haydelisa Maderazo, Provincial HIV Program Coordinator. This set the stage for participants to better understand the local context and the pressing need for policy reform.

The lecture proper began with an overview of Republic Act 11166, the

Philippine HIV and AIDS Policy Act, designed to familiarize participants with its key provisions. To deepen their knowledge of effective policymaking, the IDEALS team of legal experts facilitated discussions on critical topics such as, Policy Framework Building, Policy Development and Systems Thinking, Identifying Interventions, Addressing Delivery Challenges, and Exploring Opportunities

Workshops and open forums were integrated throughout the sessions, ensuring a participative and thorough understanding of the concepts discussed.

The writeshop concluded with the creation of an action plan, in which participants identified strategies, key activities, and specific timelines to achieve the goal of endorsing the proposed legislation to the S a n g g u n i a n g

The Importance of Upholding GCV and Discouraging Black Market Sales

November 28, 2024 – In a bold statement aimed at protecting the integrity and future of the Pi Network, the Global GCV Core Team has issued a call to action for all Pi pioneers, ambassadors, and merchants to take a stand against the black market trade of Pi coins. This comes as the network prepares for further expansion and adoption on a global scale, and aims to uphold the Global Consensus Value (GCV) of \$314,159, which the team says is essential to preserving the value and credibility of the ecosystem.

The Global GCV Core Team emphasizes that the sale of Pi coins on unauthorized markets directly undermines the core principles of the Pi Network. Not only does it erode the trust of the community, but it also jeopardizes the network's credibility, diminishing the value of the ecosystem that Pi pioneers have worked so hard to build. Upholding the GCV is seen as a vital part of maintaining confidence in Pi's longterm potential and creating a unified economic model that reflects fairness, transparency, and collective growth.

Upholding the GCV: A Shared Responsibility
The Global GCV Core Team's message is clear: every member of the Pi community has a role to play in ensuring the network's success. From individual pioneers to businesses and merchants, all must act as advocates for the network by discouraging

illicit Pi sales, promoting the GCV, and educating others on its significance. "Upholding the GCV of \$314,159 is a reflection of our confidence in Pi's future," said Lumari, Executive Director of the Global GCV Core Team. "It's a symbol of the collective effort and vision that has brought us this far, and it is essential for ensuring the credibility of Pi as a legitimate and stable digital currency."

Merchants, in particular, are urged to take on a leadership role within the Pi ecosystem. By adopting Pi as a payment method and setting an example of ethical trading practices, they can influence the broader community and set standards for responsible commerce. Additionally, merchants who actively promote Pi and the GCV contribute directly to the network's growth and legitimacy.

The Role of MapofPi: Empowering Merchants and Expanding the Ecosystem One of the key initiatives is championing to support the network's growth is MapofPi, a platform designed to connect Pi users with merchants who accept Pi coins. Currently, MapofPi boasts 50,000 registered sellers, but the ambition is to expand to 100,000 merchants globally. This goal is central to building a vibrant, global marketplace where Pi users can exchange goods and services, further integrating Pi into the global economy.

Merchants who join MapofPi gain significant benefits:

1. Increased Customer Reach: Access to a growing and engaged community of Pi users eager to support businesses that accept Pi as payment.

2. Free Advertising: Unlike traditional marketing, merchants on MapofPi receive free promotion and visibility across the network.

3. Early Adoption Advantage: By accepting Pi early on, businesses position themselves as innovators, attracting forward-thinking customers and partners.



Dengue cases in Cavite reach more than 10K

TRECE MARTIRES CITY, Cavite — The Cavite Provincial Health Office (CPHO) and concerned agencies have taken measures to stop dengue as 10,119 cases have been recorded this year.

Data released by the CPHO on Saturday showed Imus City has the most cases with 1,532, followed by Bacoor 1,500, General Trias with 1,183, Dasmariñas with 1,101 cases, Trece Martires City with 904 cases and Tanza with 847 cases.

Provincial health officer Dr. Nelson Soriano said that 43 fatalities (.42 percent) were recorded this year, much higher than last year that saw only five deaths.

Most of those affected by the disease are male with 5,345 or 53 percent. About 6,970 or 69 percent of affected individuals were admitted to the various hospitals.

"Here in General Trias, we are nonstop in our fogging and misting operation. Open communication with barangay officials and coordination in the high-burden barangay," Dr. Jonathan Luseco, city health officer of General Trias, told The Manila Times in a telephone interview.

Luseco said that Mayor Jon-Jon Ferrer has procured chemicals to be used in anti-mosquito operations.

He added they are taking an inter-agency approach to fogging with City Environment and Natural Resources Office (Cenro) and general services office (GSO), along with their fumigators, in collaboration with the city's 33 barangay (villages).
