According to Dano Tingcungco's report in 24 Oras, no one was injured or died from the incident. However, many residents lost their possessions to the fire.



DepEd highlights leadership change, shift in direction

THE Department of Education (DepEd) experienced a pivotal year in 2024, marked by a change in leadership and a renewed focus on digital education.

Following a political upheaval, Vice President Sara Duterte's departure in July set the stage for the appointment of Sen. Sonny Angara as her successor. This leadership shift signified a major change in the department's policies and direction. Early initiatives: Addressing key issues

DOH logs total of 101 fireworks-related injuries as of Dec. 27 The Department of Health (DOH) on Friday reported 32 more fireworksrelated injuries (TWDIs) in Priday reported 32 more fireworks-

related injuries (FWRIs) in various regions, bringing the overall tally to 101 from Dec. 22 to 6 a.m. of Dec. 27.

In a Bagong Pilipinas Ngayon interview, DOH Assistant Secretary and Spokesperson Albert Domingo said the top three regions with the most number of FWRIs are the National Capital Region, Central Luzon and Cagayan Valley.

"Top four is Western Visayas, and then top five, two regions are tied -Ilocos and our Central Visayas," he said.

He noted that the FWRIs were generally caused by illegal firecrackers – boga, five star and piccolo which accounts for eight in every 10 cases.

"Pati iyong kuwitis pumasok na rin – kahit legal siya, siya rin ay nagiging top four na dahilan ng ating mga fireworks injuries (While kwitis is legal, it has become the fourth top cause of fireworks injuries)," he said.

Of the 101 cases, 80 or 79 percent were caused by illegal fireworks. About 65 or 64 percent were active users of firecrackers or they lit the firecrackers themselves.

Ninety-two were males and nine were females. Eighty-two were ages 19 and below while the 19 are ages 20 and above.

firecrackers)," Domingo said. Among the FWRIs, the most affected body parts are the eyes, hands, head,

calf, leg, and arm, he noted.

In case of injury, Domingo advised that first aid may be performed before going to the hospital for proper treatment and tetanus

He said pressure must be applied on bleeding wounds to avoid blood

Non-bleeding wounds be čleaned may immediately with soap and running water. Nonetheless, victims must go to the hospital for proper treatment.

GCV HAS ONLY ONE \$314,159 AND WHY WE NEED TO BUILD AN ECOSYSTEM USING GCV

Dear Global Pioneers,

I hope this message finds you well, and I would like to extend my warmest wishes for a joyful holiday season.

Upon reviewing our community dynamics, I wish to address several important points of clarification.

- Firstly, it is imperative to note that the GCV is established at \$314,159 USD, not \$3,141.59, as some misleading information may suggest. Certain unknown sources said Github CT code use 314,159 means cents rather than USD, which created confusion among pioneers. It is crucial to emphasize that GCV to cents is unnecessary. A review of our Pi wallet reveals that the accuracy extends to

seven decimal places, allowing for pricing of the products and services at US cents already when we use GCV \$314,159.

Our collective efforts have resulted in the creation of over 5 million GCV data entries, representing more than 80% of authentic barter blockchain records. To illustrate the principle involved, consider the analogy of planting watermelon seeds won't yielding beans; We created \$314,159 as GCV, it won't be changed to \$3141.59. You must understand anyone can write code on Github. So please don't drop in someone's trap. It must be understood that CT can only accept the value generated by pioneers on blockchain and GCV \$314,159 has been confirmed and it satisfies Pi Network long term goal of Pi. If it is not confirmed, CT won't mention the OM date. Because if there is no GCV , OM is impossible since if OM, it will be disaster for Pi Network.

- It is essential to refrain from utilizing price to describe Pi value, rather, we should use value to describe Pi. The process through which we created GCV data is analogous to coin coinage. Historically, governments determined the metal content of their coins. Should bad coin practices emerge, such as reducing the weight of copper or silver or gold, significant penalties would be imposed, as such actions threaten to destabilize one country's economy. This principle is directly applicable to the Pi Network; when the global OM, CT must recognize and accept the value of Pi coins created by pioneers, GCV \$314,159. For the OM to flourish, it is vital that the entire ecosystem respects and adopts this GCV, otherwise, it risks chaos which definately destroy Pi Network.

Moreover, it is crucial to understand that businesses, particularly large enterprises, will be hesitant to accept Pi as a form of payment in the absence of a defined GCV. No merchant is inclined to embrace a currency lacking a stable value.

- This necessity for a clearly defined value elucidates why CT requires additional time prior to the initiation of OM. The delay is not solely attributed to the discrepancies in KYC and migration figures; it also reflects the need for the ecosystem to generate further data utilizing GCV. We must foster an environment where more businesses accept Pi as payment to enhance the foundational integrity of our ecosystem. The greater the number of enterprises willing to accept Pi and acknowledge GCV, the more secure and expedient the transition to OM will be.

- A question often posed pertains to how businesses may engage in our ecosystem prior to the implementation of OM, particularly when they require cash flow to sustain the operation. As I have consistently advocated, our strategic approach involves a combination of Pi and fiat currency. This dual model enables various types of businesses to participate without concerns regarding tax payment in fiat to government while ensuring they can cover operational costs. Additionally, this approach allows them to achieve modest profits and broaden their customer base through our promotional efforts

- It is important to recognize that we are entering a real business environment

when we build up ecosystem. We should not impose expectations upon businesses to operate as a charity. Instead, we must create a fair, competitive, and motivational business landscape. Ultimately, businesses prioritize profitability, and our community is well-equipped to support them in realizing this objective.

- The community's goal is to strengthen the GCV and attract more businesses to accept Pi as payment and adopt GCV. Pioneers should partner with all ecosystem participants to benefit everyone involved. Businesses need more customers and profit, while pioneers seek a wider range of products with lower fiat payment options and the creation of more GCV data before OM. Most importantly, the Pi Network needs diversified businesses for success after the OM. Pioneers can benefit from a system that allows for partial fiat and partial Pi payments, enabling them to spend less fiat on groceries and necessities in the maximum 90-day period. This will lead to a stronger ecosystem after OM with full Pi payment options at GCV.

- All pioneers should understand that requiring businesses to accept full Pi payment before OM is akin to asking them to bankrupt. It will deter businesses from joining the Pi Network. Businesses can only develop when they can achieve profit and benefit; they are not charities that must endlessly satisfy the desires of pioneers. We must respect market rules. Pioneers should shift their purchasing habits from outside the community to inside it, allowing the outside world to see the value of joining the Pi Network. This helps businesses gain profits and benefits, which encourages them to introduce their suppliers to join us ASAP. This is very important to create production chain so that we don't need FIAT in the futuer.

* I hope all pioneers can grasp our goals and strategies. Our objective is not just the OM; instead, we aim for a successful OM, accompanied by long-term sustainability and prosperity.

What should pioneers do?

1. Only accept GCV \$314,159 barter and avoid any involvement in the black market. Do not engage in any non GCV Pi value barter.

2. Actively distribute the Pioneers Handbook to every pioneer around you, and ensure you read it five times.

3. Introduce more businesses to join the Pi Network and explain the benefits of participating right now. The Web 3.0 blockchain will position them advantageously in future market competition. By accepting partial Pi payment with GCV, they can gain fame and attract customers. Also we will OM in max. 90 days which means they can occupy the market earlier with no any cost and after OM, the Pi can be exchanged to FIAT.

4. Assist yourself and your team in completing the checklist.

- Remember, the long-term success of the Pi Network depends on the collective hard work of all pioneers. When we unite to cultivate the GCV ecosystem, we will attract the attention of large corporations, banks, governments, and organizations. Our own power and success must come first. They support us only when we success and they need to get benefit.

Too many pioneers are mistakenly waiting for governments and banks to provide funding or for corporations to offer high-end products. This approach is misguided. These entities will not take risks to support the Pi Network if we only seek to take advantage of them. They need to see the value in partnering with us. If we cannot provide them with benefits, why would they choose to support us?

Government funding comes from taxpayer money, and they cannot use citizen taxes to give to pioneers when citizens are struggling. Corporations are focused on profit, and banks seek returns too. They will not provide support to us if the Pi Network lacks a strong ecosystem. It's essential to remember this!

- The solution lies in pioneers partnering with CT. By uniting, we can build a powerful ecosystem that others will want to engage with. They will recognize the value of our blockchain and our pioneers as users, relying on our Pi coin for stability and convenience and for future international settlement payment.

I urge every pioneer to read this message carefully and align our mindsets toward a common goal. Let's ignore distractions and set aside conflicts. Together, we will support one another and propel the Pi Network to great success. Only through hard work can we achieve our dreams. (Doris Yin - Founder GCV Movement)

The department also launched two key initiatives in January as part of its Oplan Kalusugan (OK sa DepEd) program: the School Mental Health and the School-Based Feeding programs.

In February, Duterte held her second, and ultimately last, Basic Education Report, reflecting on her achievements during her 19 months as education secretary. She highlighted several major programs, including a partnership with the World Bank to assess teachers' salaries and the removal of administrative tasks for teachers — reforms later formalized in a department order.

Challenges and recommendations

Dr. Karol Yee, executive director of the Second Congressional Commission on Education (Edcom 2), said there were "severe inequities" in the distribution of the Special Education Fund and the

School Maintenance and Other Operating Expenses (MOOE) budget.

Yee also pointed out that, in some schools, as much as 30-70 percent of their budgets were consumed by electricity bills alone.

Duterte also introduced the "DepEd Digi-Ed 2028" program, which aims to provide better interconnectivity between schools and DepEd offices, schoolwide expand wireless access, and offer electronic textbooks to learners. As part of this initiative, DepEd planned to require bidders for the Matatag K-10 curriculum textbooks to include electronic versions for students to access at any time.

A controversial issue

arose when DepEd weighed in on the possibility of foreign schools establishing operations in the Philippines amid proposals to amend the economic provisions of the 1987 Constitution. Thensecretary Omar Romero voiced the department's opposition, citing concerns over potential threats to national security, Filipino identity and culture if foreign entities were allowed to own schools in the country.

Adjustments to the school calendar

The summer heat highlighted challenges with the current September-to-May school schedule. A high heat index forced widespread class suspensions, prompting the department to shift from face-to-face learning to alternative delivery modes. In response, DepEd moved the end of School Year 2023-2024 to May 31 and set the opening of School Year 2024-2025 for July 29. This change was part of a gradual transition back to the traditional school calendar, with full restoration expected by School Year 2026-2027.

Leadership change and new direction

As preparations for the new school year progressed, the unexpected resignation of Vice President Duterte as education secretary set off a wave of speculation. The crack in the relationship between Duterte and

President Ferdinand Marcos Jr. led to Angara's appointment as her successor. Angara, the chairman of the Senate Finance Committee and a co-commissioner in Edcom 2, was viewed as someone who understood the sector's challenges.

Upon taking office, Angara thanked President Marcos for the opportunity to lead DepEd and pledged to continue Duterte's initiatives. Despite a few reservations from educational groups, who preferred an educator over a politician for the post, Angara received a warm welcome from many, including Duterte, who joked, "Welcome to chaos."

In a news release on Monday, Senate Majority Leader Francis Tolentino described the law's signing as a historic step for Philippine sports and reflects the country's determination to excel beyond its tropical identity.

"Being a tropical country should not hinder the Philippines from dreaming of success at the Olympics," Winter Tolentino said.

"Just as our athletes have brought honor to the nation in the Summer Olympics, we aim to make strides in winter sports," he added.

Korovin, who partners with Filipina figure skater Isabella Gamez, has represented Philippines in international competitions since 2022 under the Philippine Skating Union.

The duo made history as the first Southeast Asian pair to win a medal in an International Skating Union competition – a silver in France in 2022 and to qualify for the World

Figure Championships in 2023 and 2024.

Their achievements also earned them a spot at the 2024 ISU Grand Prix of Figure Skating, further solidifying their place in Philippine sports history.

The pair now sets its sights on the Asian Winter Games in China in February and qualification for the 2026 Winter Olympics in

During the Senate deliberations, Korovin expressed his gratitude and commitment to inspiring young Filipino skaters, saying he now considers the Philippines his home. (PNA)

The closure of all POGOs in the country is in line with President Ferdinand Marcos Jr's order that he first made during his most recent State of the Nation Address.

"Considering na hindi pa po namin tapos bayaran ang mga utang namin dito so we are open to any suggestions. But now, we just want to show everyone na sarado na ang island," said Ron Lim, general manager of First Orient.

(Considering that we have yet to pay our debt, we are open to any suggestions. But now, we just want to show everyone that the island is closed.)

Due to the closure of the POGO hub at Island Cove in Cavite, 15,000 employees, mostly Filipinos, have lost their jobs.

In total, there are approximately 40,000 displaced workers as a result of the POGO ban.

Among them are vendor Annabelle's three children and her son-inlaw. She also stopped selling outside the POGO

"Matagal na akong walang income. Ngayon, naghahanap ako ng pupwestuhan kung saan ako pwedeng magtinda," Anabelle said.

(It's been a while since I lost my livelihood. Now, I'm looking for other places where I can sell.)





Largest POGO hub closed in Cavite

After authorities closed the largest POGO hub in Kawit, Cavite, there are no more Philippine Offshore Gaming Operators (POGO) in the country, according to the Philippine Amusement and Gaming Corporation (PAGCOR).



In Jun Veneracion's Tuesday report on 24 Oras, several government officials inspected the POGO hub in Cavite from its dormitory to its gaming areas before securing the property with a padlock.

It was built on a parcel of land owned by Interior Secretary Jonvic Remulla's family, which was sold in 2017.

"As of last month, wala ng kuryente ang mga buildings dito. Pinatay na. So, makikita nyo naman wala ng signs of habitation dito. Wala ng signs of business," Remulla

(As of last month, the buildings have no electricity. So, as you can see, there are no signs of habitation and business.)

'Sa umagang ito na sinara na po natin ito wala na pong hub na natitira dito sa ating bansa," PAGCOR chairman Alejandro Tengco said.

(On this day, when we shut it down, there are no more POGO hubs in our country.) The operator is facing problems in dealing with the 30-hectare property and its 57 illdings.
