ORDER

Before this Court is a petition for accreditation of *Sunday Tribune News Publishing* filed by its publisher and editor-in-chief, Arnel P. Reyes.

On November 8, 2024, petitioner presented the original/certified true copies of the annexes attached to the petition. On November 13, 2024, it also submitted the notarized affidavit stating that it is not a newspaper or periodical owned by the same person whose newspaper or periodical has already been accredited within the province where its principal office is located. Finally, on December 9, 2024, it submitted copies of the official receipts of payments of its subscribers as proof of bona fide subscription list of paying subscribers.

Per Sheriff's Report dated October 11, 2024, the principal office of petitioner is indeed located at 155 Panamitan, Kawit, Cavite.

After perusal of the allegations of the petition as well as its supporting documents and taking into account petitioner's verified declaration that it is

duly registered with the Department of Trade and Industry; it has its principal office and is of general circulation in the Province of Cavite; it is edited, published, and circulated in the Province of Cavite; it has been regularly published for at least one (1) year before the date of the application for accreditation; it does not merely reproduce or reprint news pages of other newspapers or periodicals within the region of the Province of Cavite; it is not participating in the raffle of legal and judicial notices in other provinces and/or cities outside the Province of Cavite; and it has no paid advertisement or commercial ad insertion as of the filing of the petition, the application for accreditation of Sunday Tribune News Publishing is **GRANTED**. Petitioner is accredited and authorized to participate in the weekly raffle of judicial and legal notices and other similar announcements to be published in the Province of Cavite.

The accreditation shall be valid for a period of <u>five (5) years</u> from today, unless sooner suspended or revoked for non-compliance with the requirements for an accredited newspaper or periodical or has violated any of the provisions of Presidential Decree No. 1079 as provided in Section 16 of A.M. No. 01-1-07-SC dated October 16, 2001.
