ORDER

Before this Court is a verified petition for accreditation filed by Sunday Tribune News Publishing represented by Arnel P. Reyes praying for accreditation to publish all legal and judicial notices in this Court.

During the *Ex-Parte* hearing on 21 October 2024, Atty. Eloisa Papa appeared as counsel for the petitioner and marked Exhibits "A" to "L" inclusive of its sub-markings to prove compliance with the jurisdictional requirements and to support the allegations in the petition.

After going over the petition and the documentary evidence presented, the following facts were established, to wit:

Sunday Tribune News Publishing is a weekly newspaper with office address at No. 155 Panamitan, Kawit, Cavite. The frequency of its publication is weekly. It officially started its circulation on August 7, 2024 and as to date, it printed 38,000 copies. The said newspaper was duly registered with the Department of Trade and Industry (DTI) with Registration No. 3993756 (Exhibit B) and registered with Bureau of Internal Revenue with TIN No. 109-511-635-00000 (Exhibit E). It has obtained and was granted Business Permit from Kawit, Cavite (Exhibit C). It also submitted its List of Subscribers, 52 issues compilation of newspaper, Sample Newspaper, Official Receipt issued by the Newspaper, Advertisement Contract, Sketch Map of the Office, and Office Pictures.



Hence, the pieces of evidence presented show that petitioner Sunday Tribune News Publishing has all the qualifications and none of the disqualifications as set forth under A.M. No. 01-1-107*SC (guidelines in the Accreditation of Newspapers and Periodicals Seeking to Publish Judicial and Legal Notices and Other Announcements and, in the Raffle, Thereof).

In view of the foregoing, the instant petition is hereby GRANTED. The Sunday Tribune News Publishing is hereby allowed to participate in the raffle of judicial, legal notices and orders issued by all the courts within the jurisdiction of the Regional Trial Court of Naic, Cavite and to publish the said judicial and legal notices and orders within the Province of Cavite. The accreditation shall be valid within five (5) years from the date of approval unless suspended or revoked in accordance with the guidelines.

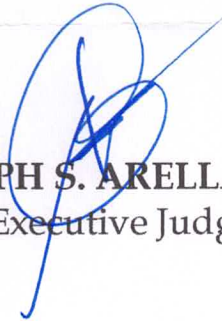
Petitioner is ordered to submit to the Office of the Executive Judge a copy of its newspaper before the date of each and every raffle participated in by it. The same is further ordered to faithfully comply with the following prescribed format by the Supreme Court appearing in its Circular No. 5-2002- dated January 11, 2002, to wit:

Title text size not more more than 10 pts.	Body text size not more than 8 pts.	Column width not less than 9 ems

Let Sunday Tribune News Publishing be included in the list of accredited newspaper, which shall be posted in three conspicuous places of Regional Trial Court Naic, Cavite, Government Center Building, Trece Martires City, Cavite, and in the respective bulletin boards of Municipal Circuit Trial Court Maragondon-Ternate-Magallanes sitting in Maragondon, Cavite, Indang-Mendez Nuñez, Indang, Cavite, and Municipal Trial Court Naic, Cavite.
