Cavite LGUs give campaign materials a second life

CAVITE – Local government units (LGUs) have launched recycling initiatives to give campaign materials a second life following the midterm elections.

In Bacoor City, 39,654 pieces or 5,549 kilos of tarpaulins have been collected by the City Livelihood and Development Office to make various recycled items. Also collected were 407 kilos of plastics and 13 kilos of tie wires, which will be forwarded to a

In Imus City, CENRO led the clearing operations in coordination with the City Engineering Office, the City of Imus Task Force for Road Clearing, barangay officials, and Bantay Kalikasan street sweepers.

CAVITE – The Commission on Elections (Comelec) proclaimed on Tuesday, May 13, the provincial leaders and district representatives who won in the midterm elections.

Abeng Remulla, son of Justice Sec. Jesus Crispin Remulla, was proclaimed governor-elect at the Provincial Legislative Building in Trece Martires.

Remulla's unopposed running mate, Sen. Bong Revilla's son Ram Revilla Bautista, was proclaimed vice governor-elect.

Speaking to the media, Remulla said he and Revilla Bautista have big shoes to fill, given their families' political backgrounds.

"We're standing on the shoulders of giants. Our job here is to make sure we forge our own paths, create our own legacies,

while taking into consideration the steps that our forefathers have done before," Remulla stated.

Transmission rates down in May 2025 electric bills

Consumers can expect lower transmission rates this May 2025, following a significant reduction in both transmission wheeling rates and Ancillary Services (AS) rates for the April 2025 billing period, NGCP

announced.

Overall equivalent average transmission rates for the April 2025 billing period dropped by 28.45% to PhP1.0904/kWh, from March's PhP1.5240/kWh.

The decrease was driven by reductions in both transmission wheeling rates and Ancillary Services (AS) rates. Transmission wheeling rates are what NGCP charges for its primary service of delivering power, while AS rates pertain to the pass-through costs for power supplied by AS providers to stabilize the grid during power supply-demand imbalance. AS charges are remitted directly to generating companies with bilateral contracts with NGCP, and to the Independent Electricity Market Operator of the Philippines (IEMOP) for

the AS sourced from the Reserve Market.

NGCP's transmission wheeling rates went down by 16.35%, from PhP0.5505/kWh in the March 2025 billing period to PhP0.4605/kWh in the April 2025 billing period.

"For the May 2025 electric bill of the end consumers, NGCP charges only 46 centavos per kWh

for the delivery of its services," NGCP explained, adding that AS still accounts for the bulk of transmission charges.

Average AS rates for the April 2025 billing period decreased by 36.07% to PhP 0.5175/kWh, compared to PhP0.8094/kWh in the March 2025 billing period.

The AS cost for Visayas for the April 2025 billing period

EMERGENT CALL TO PIONEERS!

The deeper reason lies in the hard work of the GCV community, including many GCV Ambassadors, and the support from our pioneers. I received a report from Mr. Yu, the Executive Director of GCV CT in China, indicating that over 200,000 Pi have been purchased recently in Huna province alone. We haven't even counted the total from around the world.

I appreciate the "Selected Works of Mao Zedong, Volume 1: On Contradiction." The worldview of materialist dialectics emphasizes studying the development of things from their internal aspects and their relationships with one another. It suggests that the development of things is due to their inherent dynamics, and their interconnections and mutual influences are crucial. Pioneers, let's strengthen our resolve. If we love and protect Pi, when we repurchase, it will build market confidence and attract more investors. All investments are driven by confidence in the potential for profits.

All pioneers should understand that the foundation of the Pi price comes from us, not external forces. While external factors can influence the market, they are not the ultimate decision-makers.

We have 60 million pioneers. If each pioneer buys 10 Pi, a total of 600 million Pi will be purchased. If each pioneer buys 100 Pi, that would require 6 billion Pi. Currently, we have only 1.9 billion Pi available, which means that if each of the 60 million pioneers buys 30 Pi, they could collectively control the Pi price. No whale can match the collective action power of 60 million. please share my articles along with those of GCV Ambassadors' articles or videos to help other pioneers focus on our common goal.

PBBM eyes strong ties with Bangladesh, Palau, Armenia, Cuba, Mongolia

President Ferdinand R. Marcos Jr. expressed his intent to enhance the Philippines' relations with Bangladesh, Palau, Armenia, Cuba, and Mongolia.

Marcos received the credentials of the five countries' new envoys to the Philippines in a ceremony at Malacañan Palace in Manila on Thursday.

"President Marcos expressed his hope that the envoys would work closely with their Philippine counterparts to continue deepening bilateral ties, and encouraged them to take time to explore the Philippines," the Presidential Communications Office

said in a news release Thursday night.

The President welcomed Bangladesh's resident ambassador to the Philippines Mohammad Sarwar Mahmood during the presentation of credentials and expressed optimism for deeper collaboration between the two nations.

He also reaffirmed the Philippines' commitment to strengthening bilateral cooperation with Palau, Armenia, Cuba, and Mongolia when he received

the credentials of their non-resident ambassadors.

The four new non-resident ambassadors to the Philippines are Peter Adelbai (Palau), Suren Baghdasaryan (Armenia), Yadira Ledesma Hernandez (Cuba), and Enkhtaivan Dashnyam (Mongolia).

Foreign Affairs Secretary Enrique Manalo joined Marcos in welcoming the new ambassadors at Malacañan. (PNA)

DA lifts pork MSRP upon stakeholders' request

The Department of Agriculture (DA) on Thursday lifted the maximum suggested retail price (MSRP) of pork following the request of the industry stakeholders.

The MSRP for pork is set at PHP380 per kg. for "liempo" (belly); PHP350 per kg. for "kasim" (ham) and pig; and PHP300 per kg. for "sabit-ulo".

In a media interview at the Bureau of Animal Industry compound in Visayas Avenue, Quezon City, Agriculture Secretary Francisco Tiu Laurel Jr. said pork stakeholders sought the lifting to give way for a recovery period.

"Iyong lifting ng MSRP sa (The lifting of the MSRP for) pork is effective today. The main reason is there's clamor in the industry na short ang supply na hayaan na silang makabenta ng (that there's a short supply and allow them to sell at) a farmgate price above PHP230," he said.

"Of course, may issue rin ng (there's also an issue on) low compliance. So, we are evaluating our

strategy in order to solve this issue and bring down the prices of pork in the near future."

Among the stakeholders who requested the lifting of pork MSRP are ProPork and the National Federation of Hog Farmers, Inc., according to DA Assistant Secretary Arnel de Mesa.

As of mid-May, the DA said the compliance with the pork MSRP remained low at 30 to 40 percent.

Tiu Laurel, however, assured that they will bring back the pork MSRP once they finalize the study and other policy reforms.

The DA, earlier, vowed to intensify the government sale of pork at a cheaper price amid the lifting of pork MSRP, with plans to increase daily live hog procurement to 500 per day from the current 100 per day.

ASF vaccines

Besides these interventions, the DA also disclosed plans to complete a locally-produced vaccine against the African swine fever (ASF) in 2028.

"Gagawa ng (We will create a) platform, and then we bid the private sector to mass produce the vaccine. Ito iyong platform, mag-produce kayo ng bakuna (This is the platform, you produce the vaccine)," DA Undersecretary Constanse Palabrica said in a press conference on Wednesday.

"So that by 2028, kapag natapos ito (once we complete it), we're not going to import more vaccines, mas magaling ang Pilipino (the Filipinos are better)."

Palabrica also emphasized the need for government support for scientists to make this possible.

"It's just a matter of the government pushing so that these scientists will help our country," he said.

Besides the completion, the DA also aims to help the country's hog industry recover before the end of this administration.

"I was tasked by Secretary Kiko (Francisco Tiu Laurel Jr.) that by 2028, we could have enough pigs pre-pandemic ASF," Palabrica said.

To date, the DA only uses AVAC live vaccines from Vietnam for the

government's controlled vaccination of healthy and ASF-negative hogs.

According to the Bureau of Animal Industry (BAI), only 86 out of the 40,000 inoculated hogs were among the logged fatalities. (PNA)

DTI-Laguna Maintains Consumer Protection through PETC Inspection in Pila, Laguna

Victoria, Laguna – Pursuant to the Department of Trade and Industry (DTI) Department Administrative Order No. 3, Series of 2002 (DAO 3:2002), the Department of Trade and Industry - Laguna Provincial Office (DTI-Laguna), through its Consumer Protection Division, conducted another onsite inspection and assessment of a motor vehicle private emission testing center (PETC) in Pila, Laguna on April 25, 2025, to ensure that accredited PETCs continuously comply with government rules and regulations as well as meet the quality standards set by the government under the Republic Act No. 8749, otherwise known as the Philippine Clean Air Act.



The onsite inspection and assessment activity of motor vehicle PETCs is one of the DTI's mandates in implementing standards and procedures on the accreditation of PETCs. This process also includes checking of their necessary tools, equipment, facilities,

expertise, and quality service; interview with their qualified technicians or motor vehicle emission control technician; and actual testing of equipment.

As part of its routine monitoring activities, DTI-Laguna will continuously inspect and monitor motor

vehicle PETCs at least once a month for this year of 2025 all throughout the Laguna Province. This endeavor seeks to protect the interest of the consumers in availing of PETC services (**ALSLinga, DTI-Laguna; Photo by ZAGavino, DTI-Laguna**).

FTI, NFA address logistics hiccups for P20/kg rice program expansion

The Food and Terminal Inc. (FTI) and the National Food Authority (NFA) on Thursday assured that efforts are in place to resolve “logistics hiccups” for the expansion of the PHP20 per kilogram rice program in the country.

The program, dubbed “Benteng Bigas Meron Na,” is being rolled out in 32 Kadiwa ng Pangulo (KNP) Centers and stalls in Metro Manila and nearby provinces.

The rollout in Luzon started on May 13 after the Department of Agriculture (DA) adhered to the assistance ban 10 days before the May 12 midterm elections.

The pilot rollout of the P20/kg rice program was held in Cebu on May 1.

In a media interview, FTI president Joseph Lo said they are continuously procuring trucks and other vehicles for easier delivery of NFA rice stocks from warehouses to KNP sites.

“Ongoing naman po iyong mga improvements na ginagawa natin katulad sa mga meetings natin weekly (The improvements that we are doing like in

our weekly meetings are ongoing),” he said.

To date, he said, 15 out of the 30 target vehicles have already been purchased for the three-phase implementation of the program nationwide.

For Luzon alone, Lo said they need 30 drivers; while talks with other local government units (LGUs) are underway to plan logistics setup in Visayas and Mindanao.

For its part, the NFA said it is working on the flexibility of shipment delivery for NFA rice stocks.

“So, I’m making the contract na medyo (somehow) flexible. So kung manggagaling ng Mindoro, dapat pwede siyang maka-deliver kahit saan (So, if it will come from Mindoro, it should be allowed to deliver anywhere else),” said NFA



Administrator Larry Lacson, citing that shipment of NFA stocks is part of their operational costs.

The NFA has started unloading 35,000 bags of NFA soon-to-age and aging well-milled rice in Cebu port from Mindoro, with the next batch of the same volume being prepped.

To date, Lacson said there are 400,000 bags of NFA rice allocated for the pilot rollout in the Visayas

region, while some 248,000 bags are available in the Valenzuela warehouse for the distribution in Metro Manila and nearby provinces.

The DA said it will expand the program in 55 KNP sites in Metro Manila in June and roll out its Phase 2 and Phase 3 in July and September, respectively, which will include areas in Mindanao. (PNA)

"Kausap na rin namin 'yung barangay captains na sa kanilang mga barangay, 'yung mga kaya nilang tanggalin na mga tarpaulin, matulungan na kami na matanggal... Mahirap kasi kung isa lang ang gumagalaw. Okay sa amin 'yung coordination with different sectors (We are in coordination with barangay captains so that in their respective barangays, they can help take down any campaign tarpaulins. It is difficult if

only one group is doing the work, so we really appreciate the coordination with different sectors)," Imus CENRO Officer-in-Charge Phoebe Januarie Camaisa told the Manila Bulletin.

As of May 13, the LGU has retrieved 80% of campaign materials in 97 barangays.

Tarpaulins in good condition will be sent to the city's materials recovery facility, where they will be repurposed

into bags, fans, and other useful items. Their recycling shop also processes rejected plastic packaging materials into woven bags.

Worn out pieces not suitable for reuse, meanwhile, will be given to partner facilities that convert tarpaulins into bricks and wall panels.

Minimizing waste rather than just managing it post-elections

While recycling helps reduce post-election waste, Calo pointed out that the best approach is to start with sustainability.

"Siguro 'yung tinatawag na digital campaign, naka-focus sa social media platforms, email campaigns, at websites. Tapos 'yung personal outreach, 'yung door-to-door approach (They can do digital campaign focused on social media platforms, email campaigns, and websites. Then there's personal outreach, like the door-to-door approach)," the environmental consultant pointed out.

"Siyempre, meron ding paggamit ng eco-friendly and reusable materials... Dapat sumunod din sa ordinance regarding proper disposal of campaign materials (Of course, there's also the use of eco-friendly and reusable materials... Candidates should also comply with ordinances on the proper disposal of campaign materials)."

In a press release issued on May 13, the EcoWaste Coalition reiterated that all candidates—winners and losers alike—should be held accountable for the waste left behind by their campaigns.

"This cycle of waste and neglect has to end. If candidates truly want to lead, they must show that they can also clean up after themselves and protect the environment while doing so," the statement said.

* Kabayabasan Elementary School – San Nicolas, Pangasinan

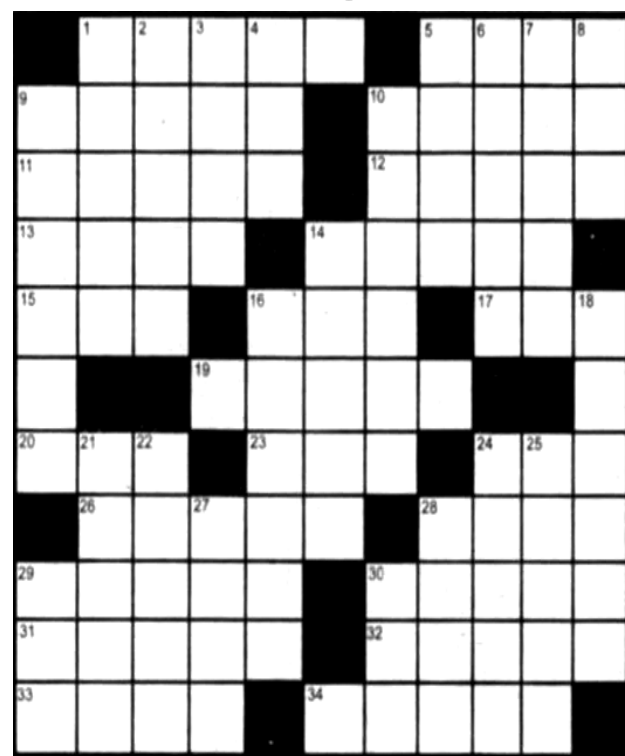
* Binmaley School of Fisheries – Binmaley, Pangasinan
