Launching of Farmers Field School project in Naic, Cavite



On May 22, 2025, the Office of the Provincial Agriculturist, in partnership with the Department of Agriculture-Regional Field Office IV A and Naic Municipal Agriculture Office, officially launched the Farmers Field School on Production of High Quality Inbred Rice Seeds and Farm Mechanization at Gracita Johnson's Residence, Malainen Bago, Naic, aiming to equip Cavite farmers with advanced agricultural methods and modern mechanisms.

Punong Barangay Lito Catibayan of Malainen Bago warmly greeted attendees, stating that he was pleased to have learned that their barangay was chosen for such a meaningful project as this would strengthen the capabilities of the farmers.

Engr. Anna Pamela Nova-Cruz, OIC-Provincial Agriculturist, together with Ms. Pamela Cordero, Naic Municipal Agriculturist; Ms. Chilina Beato of RFO IV-A; and Mr. Ruben Perlas of APCO-Cavite, graced the event, expressing their support and commitment to empowering farmers with in-depth knowledge to foster a sustainable and resilient farming sector amid the challenges of the

modern economy.

Ms. Lilian Telmo then provided the thirty-six (36) participating farmers with a deeper understanding of the Farmers Field School by delivering an overview of the project, highlighting its scope and expected outcomes.

In addition, a pre-test was administered to gauge the farmers' current understanding and align their expectations regarding rice production.

The FFS project is initiated not only to teach the ABCs and know-how of rice production, but also to provide on-hand experiences and practices for a long-term impact to the farming sector. (J. Reyes)

Smart Solutions for Every Juan: DOST Unveils Inclusive Innovations in RSTW 2025

The Department of Science and Technology (DOST) underscored its commitment to inclusive innovation and sustainable development during the 2025 Regional Science, Technology, and Innovation Week (RSTW) held in MIMAROPA. With the theme "Building Smart and Sustainable Communities," this year's celebration went beyond showcasing technologies—it became a rallying point for transforming communities through science-based solutions.



Leading the event was DOST Secretary Dr. Renato U. Solidum Jr., who emphasized the agency's vision through the banner commitment OneDOST4U—Solutions, Opportunities for All. "It is more than a program. It is a promise. A promise that every Filipino—regardless of location or livelihood—deserves access to the tools of science, to the opportunities of innovation, and to the hope that

development brings," Secretary Solidum said in his keynote address.

DOST Undersecretary for Regional Operations Engr. Sancho A. Maborang echoed this message, highlighting the agency's role in empowering communities. "Walang maiwan sa agos ng agham at inobasyon—kasama ninyo ang DOST. We will be here to nurture and guide your every step of the way," he assured participants.

A central highlight of the celebration was the Smart and Sustainable Communities Program (SSCP), DOST's flagship initiative that places people and local contexts at the heart of innovation. resilience, improve services, and drive inclusive growth.

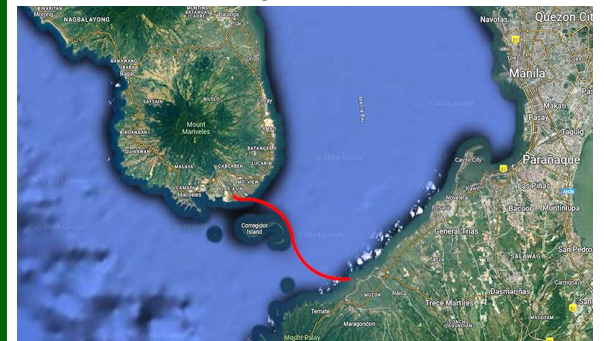
From coastal barangays in Palawan to upland areas in Mindoro, SSCP proves that no community is too remote for progress when solutions are grounded in science and local realities.

Bataan-Cavite Interlink bridge construction expected soon

THE Department of Public Works and Highways (DPWH) said construction of parts of the Bataan-Cavite Interlink Bridge is set to start before July.



"We are in the process of finalizing the bids and maybe we can begin the construction of two contract packages in a few months, the land-based packages before July," Public Works Secretary Manuel M. Bonoan told reporters on the sidelines of a briefing on Monday.

The construction of the actual bridge and its main structures will start after the construction of the land-based contract packages, Mr. Bonoan

said.

The Bataan-Cavite Interlink Bridge project is estimated to cost \$3.91 billion.

In 2023, the Asian Development Bank (ADB), co-financing the project, approved a \$2.11-billion loan for the bridge. The government is responsible for the remaining \$664.23 million.

The 32.15-kilometer bridge spanning the mouth of Manila Bay connects Bataan and Cavite, and is expected

1. On May 2nd, 2025, there is CT announcement "Expanding Accessibility to Pi Mainnet Ecosystem Through New Wallet Activation Opportunities."

Inclusivity is central to Pi's vision, and the recent updates to the Mainnet ecosystem enhance accessibility for identity-verified individuals, including fully and tentatively KYCed Pioneers.

The new wallet activation feature allows these Pioneers to activate their wallets on the Pi Mainnet blockchain, broadening participation and inclusion within the ecosystem. Also, CT open the door for non-users who can do KYC from third party Banxa and then buy Pi from exchange market to attend ecosystem. Banxa not only open to non-users, but it also opens to pioneers who need to take KYC. CT notified pioneers Banxa has some regions limitation based on their business scope. So pioneers can contact with Banxa if it hasn't opened to your region. And CT will cooperate with more third party to resolve some regions pioneers cannot join this KYC program. This expansion enhances Pi's utility by enabling more users to own and utilize Pi directly on the blockchain.

Additionally, the growth of Mainnet Wallets benefits the overall ecosystem, providing developers and apps with a larger participant base, thus driving transactions and feedback for faster development.

Always beware of third-party services claiming to be integrated with Pi that aren't listed on the official KYB services webpage, as this could lead to scams or fraud.

2. On May 14th, 2025, there is CT announcement "Launching Pi Network Ventures: Investing \$100M in Innovative Startups".

This announcement marks a pivotal moment for the Pi community as the Pi Foundation announces the launch of Pi Network Ventures, a \$100 million initiative aimed at investing in startups and businesses that enhance the utility, adoption, and real-world impact of Pi.

Pi Network Ventures, developed by the Pi Foundation, aims to steer the long-term growth of the Pi ecosystem. This fund comes from the 10% of tokens allocated for foundation reserves. With the recent launch of the Open Network, this initiative is set to create impactful utility and integration of Pi in the real world.

The initiative focuses on three key objectives:

1. ****Boost Pi Utility: **** Support businesses that incorporate Pi into their offerings.

2. ****Enable Real-World Production: **** Invest in startups that develop real-world production on the Pi Network.

3. ****Bring Pi to Life: **** Foster applications that showcase Pi's value as an accessible cryptocurrency.

Pi Network Ventures aims to invest in a range of companies, from early-stage startups to more established ventures, strengthening Pi's utility across diverse technology sectors like AI, FinTech, and e-commerce. This approach mimics traditional venture capital processes, ensuring the identification of impactful businesses.

Benefits for Pioneers include increased utility as more companies accept Pi, creating a stronger ecosystem with diverse use cases and opportunities for involvement. Overall, Pi Network Ventures is designed to align investments with the needs of the Pioneer community, driving significant growth and real-world integration of Pi. The investment will combine USD and Pi coins. There is application form for companies to apply online.

3. On May 23rd 2025, there is CT announcement "Ecosystem & Feature updates" ****New Apps Join the Mainnet Ecosystem Interface****

A new group of five Pi apps has been added to the Mainnet Ecosystem Interface, reflecting ongoing growth in the Pi app landscape. This includes a snake game, e-commerce platforms, and apps providing Pi token information. These apps have met the network's standards for quality, functionality, and compliance with Pi ecosystem guidelines.

The addition of these apps enhances the options available to Pioneers and sets a positive example for future developers. As the ecosystem grows, it becomes more attractive for community innovation and real-world utility.

Please note that the Mainnet application list does not encompass all available applications. Numerous third-party directories may provide a more extensive selection of Mainnet and Mainnet-ready applications for Pioneers to investigate.

Upon reviewing the three announcements, I will present an analysis regarding the rationale behind these announcements. It has come to my attention that many

Pioneers are expressing disappointment with the decentralized applications (DApps), as they do not meet their expectations and do not support the GCV. Consequently, many Pioneers are concluding that GCV has not succeeded. I will now offer my analysis to illustrate how the strategies outlined above can ensure the success of GCV, if Pioneers adhere to the Global GCV CT strategies. This alignment with the CT strategy is crucial. My sub-topic is: "Retreat in Order to Advance strategy" to answer pioneers questions regarding GCV ecosystem start. I will clarify this concept.

Firstly, it is essential to recognize the mission and vision of Pi Network. The overarching goal is to establish cryptocurrency on a global scale. The following information is excerpted from the 2019 white paper. We observe that Dr. Nicolas Kokkalis and Dr. Chengdiao Fan possess a mission that markedly differs from that of traditional cryptocurrencies. Their objective is to empower everyday individuals rather than catering to the interests of a select few. The white paper states that 87% of Bitcoin is held by merely 1% of its holders. Additionally, Bitmain, one of the largest mining operations in the Bitcoin ecosystem, has amassed billions in revenue and profit. This context clarifies the intent of Pi Network: it seeks to find solutions to current financial challenges through blockchain technology, rather than pursuing short-term profits for a minority.

"Our Mission: Build a cryptocurrency and smart contracts platform secured and operated by everyday people."

Our Vision: Build the world's most inclusive peer-to-peer ecosystem and online experience, fueled by Pi, the world's most widely used cryptocurrency.

Bitcoin was the first to show how cryptocurrency could disrupt the current financial model, giving people the ability to make transactions without having a third party in the way. The increase in freedom, flexibility, and privacy continues to drive the inevitable march toward digital currencies as a new norm. Despite its benefits, Bitcoin's (likely unintended) concentration of money and power present a meaningful barrier to mainstream adoption. As Pi's core team has conducted research to try to understand why people are reluctant to enter the cryptocurrency space. People consistently cited the risk of investing/mining as a key barrier to entry."

Secondly, to understand the objectives of the Pi Network, it is essential to clarify the relationship between the pioneers and the Core Team (CT). Given that the Pi Network is not intended for speculative activities, our primary focus must be on constructing an ecosystem that facilitates the use of Pi as a payment method, thereby establishing it as a legitimate currency. To achieve this goal, we must concentrate on two key areas: blockchain technology and commercial viability. The CT is responsible for the technological aspects, while the pioneers are tasked with ensuring the commercial viability, which entails fostering a consensus regarding the value of Pi. Please pay attention CT is not allowed to guide Pi value or price. This is pioneer's task. So please don't ask CT to guide how to do it. You should follow Global GCV CT guide for value and price because GCV community is the only one official community. And Global GCV CT has the authority to guide Pi value and price and provide the strategy.

Every currency requires a defined value, and thus it is vital to ascertain the value of Pi. During the enclosed mainnet phase, we dedicated three years to successfully define one Pi's value as \$314,159, which we refer to as the GCV. This value is supported by most of the community, as evidenced by blockchain records. Consequently, the GCV is identifiable within the code. At this stage, it is unnecessary to seek validation from the CT regarding the acceptance of the GCV. Dr. Nicolas has indicated that Pi's value is generated by the pioneers, and with the CT's establishment of an Open Network, we have attested to the GCV through more than 80% of real transactions over the past year. Should the CT refute this, they would not open the network. The logic here is straightforward.

We have successfully established a strong adoption of the GCV among the pioneers. As of February 20, 2025, we are on the Open Network; therefore, our focus must now shift. The pioneers must now actively help GCV in the exchange market by not selling Pi and buyback Pi. Some pioneers may express confusion as to why we go to exchange market. The primary reason is that Pi's vision centers around functioning as a currency, which necessitates widespread adoption. Without access to an exchange market, potential **► GLOBAL 2ND • 3**

This blog post explains why, and reaffirms the Core Team's vision of building a trusted, safe, and utility-rich digital economy.

Why Doesn't the Interface Show All Mainnet Apps? The blog clearly outlines that the Mainnet Ecosystem Interface is a curated gateway. Apps are selectively displayed based on rigorous criteria that ensure they: Comply with Pi's ecosystem policies.

May 30, 2025 — The Pi Core Team has issued an important clarification regarding the Mainnet Ecosystem Interface, shedding light on a matter that has sparked curiosity across the Pi community. In their latest blog post, the team emphasized that the apps shown within the Interface represent only a subset of the full

Deliver a safe and meaningful user experience. Align with the broader mission of enabling real-world utility for Pi. Demonstrate quality, innovation, and potential for impact. These standards protect Pioneers from scams, technical failures, or apps that have not yet proven their readiness or trustworthiness. The Interface is not a directory—it's a carefully managed space for verified and policy-compliant apps that are ready for mass Pioneer use.

A Broader Ecosystem Exists Beyond the Interface

The Core Team acknowledges that many other third-party Pi apps—including well-developed and community-driven platforms—exist and operate successfully outside the Interface. Some of these serve as directories that showcase a wider range of apps, including those that are fully operational on Mainnet or nearing readiness.

These third-party platforms offer Pioneers expanded access to innovation, allowing them to discover:

Early-stage apps building utility for Pi in commerce, gaming, social engagement, and finance.

Tools that promote Pi adoption across local economies.

Community-built services that reflect regional creativity and collaboration.

The Core Team invites users to explore these external apps—but also urges caution. Since these are not part of the curated Interface, users are advised to perform their own diligence and avoid apps that may compromise their trust or digital assets.

Summary of Key Points from the Blog:

The Mainnet Ecosystem Interface lists only selected apps, chosen under strict quality and compliance guidelines.

This curation ensures trust, safety, and alignment with Pi Network's long-term vision.

Many other Pi apps exist on Mainnet but are not listed

in the Interface.

users outside the network would face barriers to entry, as registration on the Pi Network and mining out Pi is often a slow process.

Additionally, merchants require a reliable avenue to convert their accumulated Pi into fiat currency to manage their operational costs effectively. Furthermore, it is crucial for Pi to attain legitimate regulatory status, enabling all pioneers and users to engage in transactions legally. WE can see a lot of countries ban cryptocurrency. However, they can accept stablecoin. This status is particularly necessary in the United States for the recognition of Pi as a stablecoin. If the Pi Network cannot be as stablecoin, many pioneers in various countries would be unable to utilize Pi as a payment method in their respective regions because the government ban cryptocurrency because of money laundry and

speculation.

It is imperative to align the external price of Pi with its internal value, the GCV. This alignment is a necessary step toward realizing Pi's vision as a currency, particularly with respect to widespread adoption and price stability. The utilization of Pi within the ecosystem requires integration of the exchange market into this framework. Some pioneers are opposed to the notion of engaging with the exchange market, mistakenly believing that purchasing Pi serves a speculative purpose. Repurchasing Pi is not for speculation, it is for hoarding. This is an essential step toward actualizing the vision of Pi as a stable currency at GVC. Only through achieving a stable price at GCV and widespread adoption can the ecosystem sustain itself effectively.

If one comprehends the logic presented above, it will elucidate the rationale behind the recent announcements made by CT, which hold significant implications for the

future. The first announcement pertains to fostering massive adoption. By extending access to a broader range of pioneers and non-users, CT aims to enhance the user base, effectively increasing the number of customers within the ecosystem. The second announcement is directed towards ecosystem merchants and service providers, enabling them to offer widely utilized, high-quality products and services. Recognizing the challenges faced by startup companies, particularly regarding price fluctuation risks, the commitment of a \$100 million investment is crucial for the long-term success of Pi.

The third announcement concerns the listing of five decentralized applications (DApps) within the ecosystem. It is evident that many pioneers may harbor disappointment regarding this development. Allow me to clarify why this strategy is optimal from CT. It is essential to contemplate the sub-topic, "Retreat in Order to Advance strategy.

strengthen local disaster preparedness and response.

It promotes homegrown science and technology as essential tools in addressing regional challenges.

In his keynote address, DOST Secretary Dr. Renato U. Solidum Jr. emphasized the role of science and community engagement in building disaster-resilient societies.

"We need systems that reach the farthest, most disadvantaged communities—early warnings via basic phones, AI-powered forecasts for farmers, multilingual chatbots, and barangay-level dashboards that enable swift action," he said.

"Fall in love with the problem, not your solutions, identify stakeholder needs," he further added.

From numerous applicants, 10 teams were selected to pitch technologies addressing flood monitoring,

emergency communication, evacuation analytics, and localized disaster information systems.

Each team presented before a panel of evaluators from the Office of Civil Defense (OCD) Region 02, Department of Information and Communications Technology (DICT) Region 02 and Advanced Science and Technology Institute (DOST-ASTI). Projects will be assessed based on scientific rigor, community relevance, sustainability, and scalability.

The winning team will be given 50,000 pesos cash prize and earn an incubation opportunity through Startup THRIVE, DOST's Technology Business Incubator hosted at ISU-Cauayan.

2nd and 3rd place will be given 30,000 pesos and 20,000 pesos, respectively.

to boost regional economic integration and development. According to the ADB, the civil works for the Bataan-Cavite Interlink bridge are divided into six contract packages. Contract package 1 or the Bataan Land approach covers 5 kilometers and contract package 2 or the Cavite Land approach covers 1.3 kilometers.

Contract package 3 involves the north and central marine viaducts; while contract package 4 covers the south marine viaducts. Contract package 5 and 6 involve the bridge's navigational channel cable and high-level approach spans.
