# Career Fest 2025: bridging education to employment for future graduates

On May 28-29, 2025, the Provincial Government of Cavite thru the Office of the Provincial Public Employment Service Manager (OPPESM) held the Career Fest 2025 at De La Salle University – Dasmariñas (DLSÚ-D) High School Complex. In partnership with the DLSU-D administration, the event brought together graduating college students and alumni of the school for a two-day event focused on career preparation, employment opportunities, and government support.

students as they transition a from campus to career, the event featured keynote addresses, career coaching, labor market insights, and job matching activities. DOLE Provincial Director Marivic B. Martinez graced the event, emphasizing the importance of career coaching for graduating students. She also encouraged participating employers to provide onthe-spot hiring to help jumpstart the careers of qualified applicants.

Cavite PESO Manager Rizalie Pinpin-Enero formally opened the program with welcome remarks, while Dr. Jeff S. DLSU-D Buenviaje, Director for Advancement expectations.

Aimed at guiding and Alumni Relations, gave message encouragement, motivating students to embrace the next chapter of their professional journey with confidence and purpose.

A key component of the event was the presentation Market Labor Information (LMI) by DOLE staff. LMI provides critical data and projections on employment trends, helping students make informed career and education decisions. Career coaching sessions led by OPPESM further enhanced student readiness, offering guidance on resume writing, interview strategies, and workplace

The event also featured a strong presence from various national government agencies including NBI, SSS, TESDA, DOLE, PSA, Philhealth, Pag-IBIG, and PhilPost, providing essential pre-employment services and support for attendees.

A total of 1,773 students and alumni participated in Career Fest 2025, making it a successful initiative in preparing young professionals for the competitive labor market. ## DOST Empowers Onion Farmers with Tech and Market Access

In a bid to revitalize the onion industry and uplift the livelihood of farmers in Occidental Mindoro, the Department of Science and Technology (DOST) is spearheading a series of interconnected science and technology-based interventions aimed at strengthening the entire agricultural value chainfrom production and processing to market access.



Local farmers have long struggled with challenges such as market saturation, the influx of imported onions, and inadequate post-harvest infrastructure—issues that have resulted in substantial financial losses during peak harvest seasons. In response, the Department of Science and Technology (DOST), through its regional office in MIMAROPA and affiliated

programs, implementing targeted interventions to boost farm productivity, minimize post-harvest losses, and enhance market access. During a recent visit to Occidental Mindoro, DOST-MIMAROPA officials inspected key initiatives that reflect their commitment to inclusive rural development through science and technology. processing facility at Occidental Mindoro State College (OMSC) – Murtha Campus, the Smart Drip System Irrigation deployed in onion farms in San Jose, and the centralized weaving center for the Ina Buhid indigenous women in Bato-Ili, Monte Claro—all of which aim to improve the livelihoods of farming communities

Kadiwa opens in Cavite police camp IMUS CITY, Cavite (PIA) — The Cavite Police Provincial Office (PPO) joined the Department of Agriculture and local agricultural offices in supporting farmers and local entrepreneurs by launching its own Kadiwa ng Pangulo store inside its headquarters at Camp BGen. Pantaleon Garcia in Imus City, Cavite.



Director Police Col. Dwight Alegre, said the store aims to provide tordable basic goods to the police force and nearby communities while empowering local farmers, fisherfolk, and small entrepreneurs.

"The establishment of the KNP Store at Cavite PPO demonstrates the Philippine National Police's active support

Acting Provincial for national programs that uplift both the general public and local producers," Alegre said.

He added that initiative reflects the PNP's broader commitment community service, sustainable development, and economic empowerment.

"This initiative directly benefits local farmers,

fisherfolk, and smallscale entrepreneurs by offering a direct market for their products while enabling the community to access essential goods at more affordable prices," he added.

Calabarzon DA lauded the Cavite PPO's move to establish Kadiwa ng Pangulo inside their camp,

promoting healthy development within the ecosystem. It's interesting to see so many rumors aimed at dissuading pioneers from making purchases. This only demonstrates that these critics genuinely believe that if we do buy, we can reach GCV.

If they didn't believe this, why would they expend so much effort to deter us? Do they actually care about the fact that many pioneers' wallets are frozen? The truth is, they don't care about your wallets; their real aim is to prevent us from succeeding.

If we buy, they will fail. Their goal is to ensure that Pi Network does not succeed because they know that a stable massively adopted currency is crucial for ecosystem.

Without GCV on the exchange market, the ecosystem won't develop properly, which is why they work hard to mislead pioneers. Look at Shenzhen in China, where they can construct a floor of a building in just one day. China's Yangtze River Three Gorges Water Conservancy Project is the largest water conservancy project in the world to date.

This project represents the culmination of human ingenuity. In 1964, China successfully detonated its first atomic bomb, announcing to the world that the Chinese

people had mastered atomic bomb technology through their own efforts, thus breaking the nuclear monopoly held by superpowers. China's colonial period lasted from the 1840s until the end of World War II in 1945. After 80 years, China emerged as a powerful global economy and military force. All of this may have seemed impossible at the time. So, how did it happen? It is because the Chinese people are diligent, wise, independent, and hardworking; we never back down in the face of difficulties.

Today, the Pi Network offers us an unprecedented opportunity to overcome poverty and make a difference in the world. Is there a second chance to change your life? No! Is this journey difficult? Not at all! If we sincerely understand our historical mission and recognize the benefits for ourselves, it becomes easier. However, everyone must have ambition and courage so that you own decisions and take action if you want to change. The Success is not dropped from heaven; it requires all pioneers to unite and show commitment. Today, your fate is in your hands! Ask yourself: Do you want to change your life? ## PAPI Appeals to PBBM: Retain Jay Ruiz as PCO Secretary

"Changing the guards mid-game sends the wrong signal," warns PAPI President Nelson Santos

Publishers Association of the Philippines, Inc. (PAPI). one of the country's largest and oldest media organizations, appealing to President Ferdinand R. Marcos Jr. to retain Secretary Jay Ruiz head of the Presidential Communications Office (PCO), citing his professionalism, journalistic integrity, and stabilizing presence in a time for crucial

government messaging. In a statement, PAPI President Nelson Santos expressed confidence in Ruiz's capacity to lead the PCO amid swirling political noise and public pressure.

"While we fully respect the ongoing evaluation being conducted on Secretary Ruiz, we believe that changing the guards in the middle of the ballgame does not bode well for the administration—especially at a time when coherent, credible communication is most needed," Santos said.

Ruiz, a veteran field

reporter and highly respected broadcast journalist, brings with him decades of experience from the front line of news coverage. His deep understanding of both the media landscape and public sentiment, Santos noted, are rare qualities that perfectly match the demands of a modernday PCO Secretary.

"We in the community press and mainstream media alike have witnessed Secretary Ruiz's commitment to fairness, truth, and the free flow of accurate information," Santos added. "At a time when misinformation runs rampant, we need someone who not only knows the job—but has walked the beat."

Santos also cautioned against the optics of frequent leadership changes in the PCO, noting that Ruiz is already the fourth press secretary since 2022.

"Another replacement at this juncture will not look good for the administration, especially now that it is beset by criticisms from various political sectors. Stability in government communication is not a luxury—it is a necessity," he emphasized.

PAPI's appeal joins the growing chorus of support from media practitioners and c o m m u n i c a t i o n professionals who view Ruiz's leadership as a much-needed anchor in the government's information efforts.

"We ask the President to weigh not just politics but performance.



Secretary Ruiz has the media's trust—and that is one currency no public servant can afford to lose," Santos concluded.

## BFAR to launch 'food boat' to support PH fishers in WPS

MANILA – The Bureau of Fisheries and Aquatic Resources (BFAR) is set to launch a "food boat" to further support the livelihood of Filipino fishers in the West Philippine Sea (WPS).

The food boat will provide both logistics support and direct market linkage, in line with President Ferdinand R. Marcos Jr.'s directives to boost local productivity and help Filipino fishers in the country.

The vessel will resemble the function of the newly launched joint project with the Philippine Coast Guard (PCG) dubbed "Kadiwa ng Bagong Bayaning Magsasaka (KBBM)" program in Palawan.

In a phone interview on Thursday, BFAR spokesperson Nazario Briguera said over PHP20 million worth of food boats will be made available to Filipino fishers by the end of the year or in early 2026.

"May barko ang BFAR na pupunta doon sa laot at may kakayahan ito na magsagawa rin ng mga yelo on board, iyong mga slurry ice para mas mapreserve iyong huli ng ating mga mangingisda (The BFAR's food boat will sail to the sea and it has a capacity to provide ice on board, the slurry ice to preserve the catch of our

fishers)," he told the Philippine News Agency.

"Ito rin ang magiging logistic support doon sa mga mangingisda sa pamamagitan ng pagdala sa merkado ng kanilang mga huli (This will also serve as a logistic support to fishers by delivering their fresh catch from sea to markets)."

The food boat has a carrying capacity of 20 metric tons (MT) each week, which would be helpful to Filipino fishing vessels, particularly during peak fishing season.

KBBM program

The newly launched KBBM, meanwhile, will benefit nearly 1,000 fishers in the WPS as it covers operational costs, provides fuel and ice subsidies, and market linkage.

Briguera said the KBBM, through the PCG's MV Mamalakaya, will transport fishers' fresh catch from the sea to major ports of Zambales, Navotas, and nearby areas of the WPS fishing grounds.

He said this is the first time that the government

is implementing such a strategy to boost the livelihood of Filipino fishers and help reduce postharvest losses.

"Ang advantage po nito, mababawasan iyong operational cost ng ating mga mangingisda dahil hindi na kinakailangan na bumalik na kaagad sila sa pampang para madala ang kanilang mga huli (Its advantage is it will reduce the operational costs of our fishers because they don't have to go back immediately to the shore to deliver their catch)," he said.

"Kundi doon sa pamamagitan ng barko ng PCG ay mismo bibilihin na yung kanilang mga huli (Instead, through the PCG vessel, their produce may be bought already)."

The BFAR official said the WPS production accounts for 13 percent of the country's total annual production on average.

The Department of Agriculture (DA), meanwhile, said the KBBM will be implemented in three phases until 2027.

These include Kalayaan Group of Islands for the first phase; Bajo de

indigenous groups by blending innovation with cultural preservation.

In addition, DOST officials visited four SETUP-assisted beneficiaries to assess their progress and identify opportunities for further support and innovation. enterprises These included the OMSC Food Processing Center cum Onion Processing Facility, which utilizes upgraded technologies to enhance the production of valueadded onion products; Ufudan mga Ina Buhid sa Aligon Gamat, a womenled indigenous group preserving traditional weaving practices while generating income through handicrafts; Tawaraw Salt Producers, a local community enterprise engaged in the sustainable production and processing of salt; and Alpha Palay Trading & Rice Mill, which has improved its rice milling operations through technology interventions aimed at increasing efficiency and product quality.

One of the core technologies introduced is the Smart Drip Irrigation System under the Smart Sustainable and Communities Program. This system enables efficient water use, minimizes waste, and boosts crop yields—key components for climateresilient agriculture. To complement this, DOST has redeployed essential post-harvest equipment Small through its Enterprise Technology Upgrading Program (SETUP), including a cabinet dryer and stainless steel tables, now installed at the OMSC - College of Agriculture's Food Processing Center in Murtha Campus.

In line with the growing emphasis on value-added production, the facility is being expanded with a dedicated Onion Processing Facility, backed by a ?10 million grant from the Department of Agriculture. The upgraded facility will house advanced equipment such as a freeze dryer and water

retort, further enhancing OMSC's capability to support both education and local agribusiness development.

To help farmers maximize available technologies, DOST-MIMAROPA, through its Provincial Science and Technology Office (PSTO), has conducted training on low-cost post-harvest techniques using locally available materials, teaching practical methods such as sun-drying, blending, and heat application. One standout product from these efforts is onion-based ice cream—an innovative creation that highlights the potential of diversification and valueadded processing to generate new income streams and extend shelf life. Complementing these agricultural initiatives, DOST-MIMAROPA also supports cultural preservation and economic empowerment through the centralized weaving center of the Ina Buhid women, which livelihood provides opportunities while sustaining traditional handloom weaving practices.

Bridging the gap between innovation and commercialization, DOST has partnered with Lazada Philippines to help micro, small, and medium enterprises (MSMEs) and farmer cooperatives expand their reach in the digital marketplace, giving locally developed products greater visibility and access to broader consumer bases. In addition, DOST continues to collaborate with the Philippine Chamber of Commerce and Industry (PCCI) and other key stakeholders to promote inclusive supply chains and scalable agri-technologies that enhance the competitiveness farmers, strengthen local enterprises, and ensure benefits wider consumers.

These initiatives reflect DOST's broader mission of transforming rural economies through inclusive innovation. By investing in R&D, enabling technology transfer, and fostering strategic partnerships, the agency is building a resilient onion


