The Philippines marked its 127th Independence Day with a celebration on June 12, 2025, in Kawit, Cavite—the birthplace of Philippine independence.

With the theme "Kalayaan. Kinabukasan. Kasaysayan," the festivities began with Parada para sa Kalayaan, a socio-civic parade featuring members of local government units (LGUs), community organizations, local institutions, and marching bands. The parade started at the Magdalo-Potol Fire Station and concluded at the historic Aguinaldo

The national program, organized by the National Historical Commission of the Philippines (NHCP), followed the early morning parade with a wreathlaying ceremony at the tomb of General Emilio Aguinaldo. Leading the ceremony was the Guest of Honor, Supreme Court Chief Justice Alexander G. Gesmundo, and it was witnessed by local officials from Kawit and Cavite, NHCP representatives, and members of the Philippine Navy Marines.

ecosystem has just made a m a j o r breakthrough: decentralized applications (dApps) have officially entered Mainnet. This development marks significant milestone for Pi Network, not just

technology, but in the journey toward becoming a practical digital economy.

These dApps span across sectors such as commerce, gaming, social networking, e-commerce, and services. With these platforms going live on Mainnet, Pi users –

for goods, services, and experiences.

But what does this mean for the community and the GCV movement?

The GCV Movement in a Critical Phase

While the Mainnet dApp launch is a technical victory, the Global Consensus Value (GCV) movement is entering a crucial strategic phase worldwide. One of the most impactful campaigns is the "Buyback Strategy with 20 Pi" – equivalent to the price of two morning coffees in many countries.

This strategy is designed to:

- * Create real transaction records with a consensus value of 1 Pi = \$314,159;
- * Encourage Pi storage while its price remains low;
- * Provide a second chance for those who missed out on mining Pi over the last 5+ years.

By using 20 Pi to "buy back" daily-use goods or services, pioneers and merchants create strong psychological and economic proof of value. It's not only a symbol of belief, but a mechanism of

Utility is the Future – and the Future is Now The launch of 25 dApps is more than a technical shift

merchants, consumers, and developers a way to connect, exchange, and thrive within the Pi economy.

As dApps increase in diversity and usage, GCV is expected to become more established. This sets the stage for:

- * Merchants to accept Pi for full or partial payments;
- Ecosystem transactions to happen within dApps;
- A decentralized economy to emerge governed by pioneers, not centralized institutions.

Conclusion: From Belief to Action

The Mainnet release of 25 dApps is a giant leap forward. It is a sign of readiness – that the Pi Network is maturing beyond its mining stage, and that pioneers are preparing for real-world integration.

Coupled with the GCV movement and the 20 Pi strategy, this marks a historical turning point where the community isn't just waiting — it's building.

Philconsa raises constitutional concerns over Senate impeachment move

MANILA - The Philippine Constitution Association (Philconsa) on Thursday said the Senate, sitting as an impeachment court, raised constitutional concerns when it returned the impeachment complaint against Vice President Sara Duterte to the House of Representatives.

Philconsa, through its chairperson former chief iustice Revnato Puno, said the Senate's action "raises grave constitutional questions and challenges the integrity of the impeachment process."

"Philconsa warns that it may constitute grave abuse of discretion and risks undermining the most fundamental principle of our constitutional democracy: that Public Office is a Public Trust," Puno said.

The Accountability of Public Officials cannot be overstressed -- and must never be evaded through procedural artifice," he added.

The Philconsa said among the constitutional

statement, concerns raised are grave abuse of discretion -whether the Senate unlawfully suspended its jurisdiction already validly acquired as Impeachment Court.

Änother encroachment on the House's exclusive power - whether requiring the House to certify compliance with the oneyear ban infringes upon the House's sole prerogative under Article XI, Section 3 of the Constitution.

Whether imposing novel requirements not found in the Constitution or Senate Rules constitutes a circumlocutory device designed to delay or defeat the trial is also a question, it said.

Another issue is

whether raising possible defenses on behalf of the respondent compromises the impartiality of the Senate as Impeachment Court.

Lastly, Philconsa said there is the fundamental question of law.

"Is the mere lack of certification from the House of Representatives sufficient to justify remand of the case and suspension of trial? PhilConsa submits that no such requirement exists under the Constitution or established impeachment practice. To create such a requirement ex post facto undermines both the separation of powers and the rule of law," Puno said.

Citing legal precedents, Philconsa said that once the impeachment court validly acquired jurisdiction, it is not lost by

subsequent happenings.
"Once the Senate is clothed with jurisdiction as an impeachment court upon receipt of the articles of impeachment, that jurisdiction cannot be lost or suspended by mere procedural acts. It remains until final resolution or dismissal by the Court itself," Puno said.

"PhilConsa calls upon the Senate to uphold its constitutional duty and proceed with impeachment trial in accordance with the Constitution and the rule of law. Any act or device that circumvents this duty gravely imperils our democratic institutions."

The group pointed out that at stake is not merely the fate of one official, but the integrity of the Constitution itself.

"Impeachment is the

people's mechanism, to enforce accountability of public officials. It must not be thwarted by procedural invention or partisan maneuver." (PNA)

MRT-7 to begin operation by 2027 -DOTr chief

MANILA - Transportation Secretary Vince Dizon on Thursday assured that the Metro Rail Transit Line 7 (MRT-7) will begin operation by 2027, before the end of the term of President Ferdinand R. Marcos Jr.

In an interview during the inspection of the MRT-7 Depot in Quirino Highway, Quezon City, Dizon said the MRT-7 has been delayed for over a decade and will finally be completed in line with Marcos' order accelerate the project's timeline.

"Kampantengkampante na ako na matatapos ang MRT-7 bago matapos ang termino ni Pangulong Bongbong Marcos. Kaya by 2027, masasakyan na ito ng ating mga kababayan (I am very onfident that the MRT-7 will be completed before the end of

President Marcos' term. That's why by 2027, the public will be able to make use of it)," he said.

In addition, he said the construction of the Common Station project will also need to be accelerated to allow commuters to transfer between MRT-7. MRT Line 3, and the Light Rail Transit Line 1 (LŘT-1).

Once completed, he said the MRT-7 will shorten travel time from North Avenue in Quezon City to San Jose Del Monté in Bulacan, in addition to alleviating vehicular traffic along Commonwealth Avenue.

"Ang laking bagay sa mga kababayan natin ito, 'yung oras na masi-save mo. Hindi na sila kailangan gumising ng madaling araw at yung trapik na mababawas Commonwealth napakaiaki (i nis is such as big boon to the public, the time they will save. They won't need to wake up at dawn and it will greatly lighten the vehicular traffic along Commonwealth)," he said.

He commended the San Miguel Corporation -- the project contractor and operator -- for creating a "best practice" that can be emulated by other rail projects of the DOTr.

"Nakita natin napakalawak ng tren. Itong railway tracks natin, wala ng overhead electrical lines. Saka ang mga istasyon, maluluwag, PWD (person with disability)-friendly. Lahat may escalator, may elevator (We can see how wide the train and railway tracks are. And there are no overhead electrical lines. Plus, the stations are roomy and PWD-friendly. They all have escalators and elevators)," he said.

To date, the MRT-7 has an overall progress rate of 83.08 percent and will serve an estimated 600,000 passengers per day during its first year of operation. (PNA)

brings history to life: Aguinaldo Shrine in Kawit: **Unfolding Philippine History**

At 7 AM, the national program commenced at the balcony of the Emilio Aguinaldo Shrine, also led by Chief Justice Alexander G. Gesmundo, in unison with simultaneous flagraising ceremonies held nationwide

This was followed by the pledge to the Philippine flag led by Kawit vice Mayor Edward Samala, Jr. Immediately after, Cavite 1st District Representative Ramon "Jolo" Revilla III read an excerpt from the 1898 Proclamation of Philippine Independence.

In his speech as Guest of Honor, Chief Justice Gesmundo encouraged everyone to use freedom as a tool for progress.

"Ang ating kalayaan ay

hindi likhang sining na itinatanghal sa museo para sulyapan natin paminsan-minsan. Dapat ito ay patuloy nating ginagamit upang mapaunlad ang ating lipunan (Our freedom is not a work of art displayed in a museum for us to glance at once in a while. It is something we must continually use to improve our society)," ne stated.

He also emphasized that change is not only achieved through conflict but can be won through everyday efforts and peaceful means.

"Hindi lamang sa larangan ng digmaan makakamit ang ninanais nating pagbabago. Ito'y nakakamit na rin sa mga hukuman, paaralan, at kung saan pa man kung

talagang gugustuhin natin (Change is not achieved solely on the battlefield. It can also be won in courts, schools, and wherever we choose to pursue it with determination)," he said.

Moreover, the Chief Justice reminded all Filipinos that freedom is not a prize but a shared responsibility.

["]Ang kalayaan ay hindi gantimpalang ibinibigay dahil natapos na ang ating pagsusumikap. Ito ay isang layuning araw-araw natino pinagtitibay (Freedom is not a reward given after our efforts have ended. It is a goal we must strengthen every single day)."

Following the morning program, the celebration extended to Freedom Park in front of the Aguinaldo Shrine, where visitors participated in a job and food fair organized for the public.

DA chief backs gradual tariff hike on rice imports

MANILA - Almost a year after its implementation, Agriculture Secretary Francisco Tiu Laurel Jr. on Thursday backed the "gradual" hike of tariffs on 5 percent broken imported rice starting late September.

The tariffs on imported rice were reduced to 15 percent from 35 percent in July 2024 to help tame rice retail prices and slow food inflation in line with the directives of President Ferdinand R. Marcos Jr.

in a statement, liu Laurel said the "strategic" increase should coincide with the harvest seasons of major global rice exporters.

"To minimize the impact on the local market, we propose timing the tariff hike to coincide with the harvest seasons of our major suppliers, around late September for Vietnam and December for Pakistan," he said.

Tiu Laurel also underscored the need for a "gradual" approach since a 20-point increase may trigger a market shock.

'À sudden increase could shock not only the local market but also ripple across the global rice trade," he said.

As of June 11, the prevailing prices of imported premium and well-milled rice in Metro Manila are PHP45 per kg., and PHP40/kg. for imported regular-milled rice, according to the DA Bantay Presyo.

The price of premium imported rice, meanwhile, ranges from PHP44 to PHP50/kg.; imported well-milled rice from PHP38 to PHP48/kg.; and imported regular-milled rice from PHP35 to PHP45/kg.

The prices of premium local rice range from PHP44 to PHP60/kg.; local wellmilled rice. PHP38 to PHP52/ kg.; and local regular-milled rice, PHP32 to PHP45/kg.; with prevailing prices set at PHP50, PHP45, and PHP40, respectively.

The DA, meanwhile, is set to bring down the maximum suggested retail price (MSRP) for 5 percent broken rice to PHP43/ka. in July to further drag down retail rice prices. (PNA)

"Hopefully by tomorrow, they will give the go-signal so that by next week we can put SOCEs one by one. It is no different from what we did with the COC (Certificate of Candidacy) when we published it," the poll body chief said.

The Comelec will post the SOCEs online for the public to scrutinize them.

"This is where the vigilance of our people is needed. Aside from political rivals, the ordinary

constituents will be able to check their SOCEs. It is everybody's obligation," Garcia said.

"This is why we want the SOCEs published so that everyone can check if the candidates are hiding anything."

The law only allows candidates to spend PHP3 for every registered voter during the campaign period, while political parties and party-list groups may spend PHP5

for each voter.

The deadline for the filing of SOCEs was on Wednesday.

Based on Comelec data, 61 out of the 64 senatorial candidates, including the 12 winners, filed their SOCEs. Meanwhile, 141 out of 154 party-list groups and 25 out of 28 political parties have also filed their respective SOCEs.

At the local level, 126 out of the 1,657 congressional candidates, 47 out of 230 candidates for governor, 41 out of 196 candidates for vice

governor, and 325 out of 610 candidates for provincial board member have filed their SOCEs as of 5 p.m. on Tuesday.

At the city/municipal level, 939 out of 3,748 candidates for mayor, 909 out of 3,472 candidates for vice mayor, and 7,285 out of 31.302 candidates for councilor have complied with the requirement.

Garcia said the Comelec's Political Finance and Affairs Department would audit all the SOCEs submitted by candidates. (PNA)



MANILA – The Commission on Elections (Comelec) said Thursday the Statements of Contributions and Expenditures (SOCEs) submitted by candidates, party-list groups, and political parties in the May 12 elections may be posted online next week.

In an online interview, Comelec Chairperson George Garcia said they are just waiting for the approval of the Department of Information and Communications Technology (DICT) on the program that will be used for the posting of the SOCEs.

"A few weeks ago, we contacted DICT. The DICT needs prior consent and approval for our program. The program for publishing SOCE is still in DICT at the moment," he said.

Garcia said they are hoping to get the approval by Friday.
