The matter had grown tense, and Zhang's family urged him to use his official influence to intervene on their behalf. But instead of issuing commands or applying pressure, Zhang Ying responded with a short

the reign poem: > "I sent a letter a thousand miles away just event. Though the original structure faded with time, During the reign

Emperor for a wall. What's the harm in giving him three feet? Kangxi in the Qing The Great Wall still stands today, But Emperor Dynasty, a small Qin Shi Huang is no longer there." These few lines carried deep wisdom: conflicts, even over small conflict between neighbors gave things, come and go — but the legacy of humility rise to a timeless and virtue can last forever.

Inspired by Zhang's response, his family moved their wall back three feet. Upon seeing this, the Wu family — moved by such grace — also retreated three feet.

In the end, what was once a battleground became a symbol of understanding. A peaceful six-foot-wide lane remained between the two homes.

This became known as Six-Foot Lane (Liuchi Xiang) — a humble space that represents the power of stepping back to create room for peace. Years later, when Emperor Kangxi heard the story, he praised Zhang Ying's wisdom and humility, and a memorial archway was erected to commemorate the the story was not forgotten.

In 1999, during the renovation of Zhang's old residence, the archway was rebuilt — standing again as a reminder of what true greatness looks like.

The True Strength of Humility In a world where people often rush to defend their pride, win arguments, or claim their "rightful space," the story of Six-Foot Lane reminds us of a deeper kind of strength — the strength to let go, to yield, to put peace before ego. Humility is not weakness.

It is wisdom. It is leadership. It is the silent power that can turn conflict into connection. Whether between families, communities, or even nations what if we could all give just three feet? The space we create by stepping back might just become the path to a more harmonious world. Yunnan coffee adds new note to global coffee map

Each cup of coffee carries the essence of its birthplace - Brazil's bold richness, Jamaica's vibrant brightness, and Ethiopia's delicate freshness. Now, Yunnan, in southwest China, is adding a new chapter to this global narrative, offering a distinctly Chinese flavor that is gaining recognition on the world stage.

This evolution was on full display at the 2025 First Gems of Yunnan **Green Coffee Competition** (Yunnan CoE Pilot Program). Held in Yunnan's Baoshan, the competition marked a milestone: for the first time, a CoE-related competition was hosted in

Yunnan. Out of 144 entries, 19 coffee samples received scores above 87 points - qualifying them as world-class - following rigorous blind tasting by international judges.

The top-scoring beans, grown in Yunnan's Lincang, fetched a record 13,000 yuan (\$1,813.65) per kilogram at auction, setting a new benchmark for Chinese coffee sales. More importantly, the competition placed the province into the purview of one of the world's most authoritative coffee evaluation systems, signaling its transformation from a raw material

supplier into a standardsetter in the global coffee sector.

Founded in Brazil in 1999, the CoE has reshaped the coffee industry by combining competition transparent auction mechanisms. Information about bean variety, processing methods, pricing, and producers is made publicly available, setting new benchmarks for traceability and quality.

During the competition, each carefully selected coffee underwent an rigorous evaluation: roasting, grinding, weighing, and on-site brewing, followed by multiple cupping sessions. A panel of over a dozen professional judges evaluated each sample on cleanliness, sweetness, acidity, mouthfeel, and flavor complexity. A Brazilian farmer named Oliveira, whose beans scored an impressive 90 points, could barely contain his excitement.

Over the past two decades, CoE competitions have been hosted in more than ten countries, spotlighting emerging producers in Honduras and Costa Rica. This has expanded the global map of valued coffee-producing regions, raising both quality standards and farmer incomes.

Producing high-quality coffee requires combination of ideal natural conditions and painstaking cultivation. The best coffee regions are typically mountainous at elevations above 1,000 meters, with marked differences between day and night temperatures and clearly defined wet and dry seasons conditions that also pose greater challenges and management costs.

Yunnan, located in the global golden belt for coffee cultivation, boasts a coffee-growing history of over a century and now produces 98 percent of China's total coffee output. Recent advancements in variety improvement, standardized farming practices, and processing technologies have propelled Yunnan forward: the proportion of specialtygrade beans rose from 40 percent in 2022 to 70 percent in 2024, while deep processing rates jumped from 60 percent to 85 percent. These traits have helped turn Yunnan coffee into a byword for premium quality.

Coffee, as a global commodity, embodies the convergence civilizations across continents. In China, its popularity has surged in

recent years. Shanghai has overtaken New York and London to become a city with the highest number of coffee shops in the world. Among younger generations, coffee drinking has become both a social ritual and a lifestyle symbol. This cultural adaptation reflects a broader ethos in Chinese civilization: the principle of harmony without uniformity, an openness to influences, global seamlessly woven into a distinctively Chinese context.

Yunnan's emergence on the global coffee stage offers the world a new flavor - literally and figuratively - through which to experience China's diversity and openness.

Looking ahead, Yunnan is poised to further strengthen its role in the global coffee industry by enhancing cultivation techniques, expanding markets, building brands, and fostering innovation across the supply chain, establishing a virtuous cycle where quality begets value, and value drives profitability. continued effort, Yunnan coffee will further shape the global perception of Chinese coffee culture. PH generates \$4.2-B in tourism receipts as of June 18 – Frasco

MANILA - The Philippine tourism sector has so far generated USD4.2 billion (PHP242 billion) in visitor receipts from Jan. 1 to June 18, the Department of Tourism (DOT) said Thursday.

Tourism Secretary Christina Frasco said the figure is up 0.48 percent, year on year.

As of July 30, the agency recorded 3,473,726 international visitors – 3.15 million foreigners and 317,536 overseas Filipinos.

In a media briefing in Makati City, Frasco said the DOT is planning to recalibrate its targets for 2025 to take into consideration the challenges the sector is currently facing.

Despite this, aggressive promotions will continue in the Philippines' top markets, including South Korea, Japan, and the United States.

The DOT, Frasco said, would also increase Philippine exposure in recent launch of direct flights from Air Canada.

With recalibration underway, Manila is likewise looking at emerging markets to boost arrivals, among them Australia, the United Arab Emirates, and India, Frasco said.

"We're taking a very close look at these exciting markets, especially India, which now has visa-free access and forthcoming direct flights to Manila, she said.

Developing products

She added that the Philippines is diversifying its tourism offerings to include gastronomy, halal tourism, cultural arts, and experiential travel.

In the same briefing, she disclosed that the DOT Kalayaan Island Group to ensure its readiness to receive tourists.

She said a tourism master plan is in the works for the island.

"I have advised TIEZA (Tourism Infrastructure and Enterprise Zone Authority) that even prior to the finalization of the master plan, it's important for us to provide shortterm interventions like jetty ports, restrooms, and the like so that while the longterm plan is being finalized and will be executed years from now, the island is already able to benefit from touristic activities," she said.

"We trust that TIEZA will the necessary coordination, public consultation, and the like, in collaboration with our fellow agencies." (PNA)

Taytay residents file complaint to nullify Laguna Lake project's 'illegal' public scoping

Organizations in Lupang Arenda (APOLA) and Samahan ng Mangingisda sa Lawa ng Taytay (SMALT) filed a formal complaint on July 30, 2025, at the Department of Environment and Natural Resources - Environmental Management Bureau (DENR-EMB) seeking to nullify the public scoping held in Taytay, Rizal, on July 14, 2025, for the Laguna Lakeshore Road Network (LLRN) Project Phase II.

The Philippine pa rin nila pinakinggan

Movement for Climate Justice (PMCJ), together with APOLA, SMALT, and other affected residents, walked out of the said July 14 public scoping after the local government unit (LGU) failed to include the organizations and other homeowner associations in the Information, and Education. Communications (IEC) campaign conducted by the Department of Public Works and Highways (DPWH) and Department of Natural

Resources (DENR). '[Kahit] naglaan naman sila ng oras para sa isang

yung hinaing ng mga tao. Itinuloy pa rin nila ang public scoping [kahit] ang karamihan sa kanilang inimbita ay di dumaan sa IEC," said SMALT Secretary Jessa Sabio. [Even though they provided a chance for a private meeting, they still didn't listen to the people's grievances. They still went ahead with public scoping even most of those they invited didn't go through the IEC.]

The residents asserted that the proceeding is void from the beginning due to egregious and systemic violations of [pribadong pulong], hindi mandatory requirements under DENR Administrative Order (DAO) 2017-15 and DAO 2003-20, as well as the fundamental principles Philippine the **Environmental Impact** Statement (EIS) System. The public scoping was initially scheduled on March 21, 2025, but PMCJ and the Lupang Arenda community halted it because of the similar disregard for mandatory processes on the part of implementing agencies.

"The DENR must ensure that its own regulations are followed by project proponents. If at the outset something as basic as public participation scoping are not properly conducted, assurance do we have that the proponent would abide by environmental laws during the construction and operation of the project? That EMB should sanction an illegal public scoping has been an observed trend across the country. Government agencies are violating their own mandate", said Aaron Pedrosa, Head of PMCJ's Legal Team.

In January 2024, fishermen led by Rizal Fisheries and Aquatic Resources Management filed a complaint with the Laguna Lake Development Authority (LLDA) to suspend reclamation activities in Laguna De Bay. Affected communities are holding the government agencies legally liable for circumventing the law.

Vicente Barlos stressed implementing agencies are literally going around the affected communities. "Ang public scoping ay ginawa sa lugar na hindi naman sakop ng proyekto. Ito ay nagdudulot ng kalituhan sa aming mga residente. Dapat sumunod ang mga ahensya ng gobyerno sa batas! Nais lamang namin na masiguro ang aming mga karapatan," he said. [The public scoping was done in an area that is not covered by the project. This is causing confusion among our residents. Government agencies should follow the law! We just want to ensure our rights.]

The provinces of Rizal, Laguna, Cavite, and other areas in Southern Luzon were placed under a state of calamity last week due

to relentless rains triggered by Habagat (Southwest Monsoon) and typhoons Crising, Dante, and Emong. PMCJ and other groups have been highlighting that climatechange-induced flooding would be exacerbated by environmentallydegrading projects such as the LLRN.

"Stakeholders to the LLRN project are not only excluded participation, they are kept in the dark as proponents and agencies alike fail to disclose relevant project information. With the Government's tacit policy of exclusion, we are left with no choice but to assert our place in the conversation," Pedrosa

17 suspects nabbed for illegal sale PALAISIPAN of text-blast machines since Dec.

MANILA – Philippine National Police Anti-Cybercrime Group (PNP-ACG) operatives have arrested in the past six months 17 individuals for the illegal online sale of text-blast machines and signal jammers, a police official said Thursday.

In a press briefing held at Camp Crame, PNP-ACG Director, Brig. Gen. Bernard Yang, presented to the media items confiscated from an alias Kian, 36, the latest suspect to be arrested by the Southern District Anti-Cvbercrime Team in an entrapment operation in Taguig City on July 22.

Kian, who was arrested for the illegal online sale of SMS blaster devices, was engaged in buy-andsell activities. He claimed the devices were part of a bundle of personal computers he had purchased online from a seller of machines pulled out from a defunct Philippine Offshore Gaming Operator (POGO).

During the operation, operatives confiscated 11 units of GSM Modem Pool (SMS blaster machines) from the suspect.

Yang said Kian is facing charges for violation of Republic Act (RA) 3846 (Philippine Radio Control Law), as amended by RA 584, in relation to Section 6 of RA 10175 (Cybercrime Prevention Act of 2012).


