Purpose of the Global Conference

Today is our 3rd Global GCV Conference.

Last year, we held four conferences. So why do we need these conferences?

What is the meaning of today's event?

There are four main reasons:

Observation and Influence

The Core Team observes the pioneers' community through our conferences to guide their procedures.

Because users — not systems — are the most important factor in any project.

Guidance and Support

Conferences help pioneers find their "home" — a place for guidance, protection, and relief from anxiety. **Education and Confidence**

We use these gatherings to deliver the best education, leveraging the knowledge and achievements of GCV leaders to awaken pioneers and build trust in Pi Network and GCV.

Global Collaboration

Different countries' Ambassadors and Envoys can learn from each other and increase their collective influence.

Understanding Today's Theme

Our theme today is:

"Mainnet Readiness: Harnessing the Power of GCV Ambassadors & GCV Industry Alliances."

Ms. Lumar gave me more than ten wonderful topics, but I chose this one.

Why? Because "OM" — Open Mainnet — is a sensitive topic.

Pioneers love it, but also worry about it.

So today, let's explore the real progress of Pi Network and GCV.

Mainnet Readiness and Understanding

When I read pioneers' comments, I see their mindset their blind spots.

I am here to help you think beyond them.

Many pioneers lose confidence because the exchange market price keeps dropping to \$0.20.

Their hearts rise and fall with the price — this is torment.

It harms their health and peace.

That's why I always say:

"Knowledge and vision are essential. No knowledge and vision is like a blind elephant that cannot see the road."

While we celebrate GCV's success every day, some pioneers lose hope or even fall into anxiety because of the price.

That's why we need conferences — to deliver correct information.

So, to understand Mainnet Readiness, we first ask: Are we on Mainnet already?

The answer is simple:

Yes — we are already on OM.

Let me give you an example.

When you prepare a beautiful dinner for your family, from shopping for ingredients to serving the meal, it may take four to 6 hours.

Now, we are in that "preparation" stage for the final meal. We start the dinner preparation, but we haven't eaten and feel full yet. This is like pioneers on OM, but still "hungry" because we are still "cooking."

From OM's start until every pioneer can use Pi for all DApps, businesses, and payments — and GCV becomes unified — it will take months or maybe a year.

I see a subway station being built near my condo. Construction began a year ago and is still ongoing. Meanwhile, construction in China DORIS YIN • 3

moves much faster.

Why? Because the level of contribution and commitment differs.

The same applies to us — if more pioneers support GCV and Pi Network, progress will be faster.

If more "family members" help prepare the dinner, we will eat sooner!

This is what "Mainnet Readiness" means —

It requires everyone's contribution.

The Role of Every Pioneer

Of course, GCV Ambassadors and Envoys carry heavy responsibility as volunteers,

but every pioneer can contribute.

The first step:

Take good care of yourself.

Do not worry.

Trust both the PCT and the GCV Core Team.

If you can do that, you are already contributing.

If you can do more — even better:

Like and repost our educational content.

Join the ecosystem — barter online or offline.

Stake your Pi to support DApps.

If you are a merchant, register on MapofPi, apply for KYB, and introduce local businesses to the GCV Industry Alliance, and help them to apply for KYB.

Please don't worry about your KYC and migration process. You should focus on your KYC and migration when it's your turn to submit. If it's not your turn, there's no need to be anxious. The CT will not open to everyone at the same time. The KYC and migration of Pi will align with the development of the Pi ecosystem.

Think of it like eating food: if you eat too quickly, you might choke and struggle to digest. With our large number of pioneers, the CT will proceed step by step. If too many people migrate at once, many may rush to sell on the exchange market, which would create excessive selling pressure. Therefore, everything must remain balanced.

As the ecosystem develops, the demand for Pi will increase, and CT will open more KYC and migration opportunities. Please keep in mind that KYC and migration are ongoing processes.

We are not just talking about Mainnet — wWee are building the future Pi economy.

GCV: From Impossible to Reality

Some pioneers said, "GCV is impossible."

But now, it's no longer about possible or impossible — It's reality.

We use a win-win strategy — partial Pi payments benefit both merchants and pioneers.

We have already created 20 million GCV data points. We don't need to ask the Core Team what Pi's value

Dr. Nicolas already told us:

"You, the pioneers, decide the value collectively and

build it collectively."

When OM launched on February 20, 2025, it demonstrated that GCV was already accepted because OM relies on GCV for its existence. It's that straightforward. However, many pioneers struggle to grasp this concept, which is why they often worry about the exchange market price being too low. As I mentioned, the value of Pi is different from its price. The Pi price on the exchange market is designed for mass adoption, allowing more people to buy and hold it. The real value of Pi comes from our education efforts, our GCV data, and the businesses that accept GCV.

Once GCV is fully implemented, the prices on all exchange markets will gradually align with GCV. CT will facilitate a smooth transition throughout this process.

Why We Need GCV

Let's recall the vision of Pi Network:

"To build the world's most inclusive peer-to-peer ecosystem, powered by Pi — the world's most widely used cryptocurrency."

And the mission:

"To create a cryptocurrency and smart contracts platform secured and operated by everyday people."

Traditional finance depends on intermediaries — banks, systems — which cause high fees and central control.

Cryptocurrency was supposed to fix this, but speculation turned it into a tool for traders, not people.

That's why Pi Network was created — to solve both problems.

And that's why GCV is essential.

Without stable value, the ecosystem cannot survive. Education Before Ecosystem

Open Mainnet is not only a technical step — it's an Pi.

educational and economic milestone.

After OM and Dr. Nicolas's Consensus 2025 speech, some pioneers misunderstood.

The price drop didn't mean failure — it meant lack of understanding.

That's why GCV Education Ambassadors are so important.

Education is the foundation of Pi's success.

We Global GCV CT launched:

GCV Ambassador System (Sept 2024)

GCV Industry Alliance Envoy System (Aug 2025)

GCV Warrior System (May 2025)

Each plays a role:

Ambassadors: community education and ecosystem building

Industry Alliance: Real business world adoption and stability of GCV

Pi Network/GCV Warriors: Promotion and massive adoption Pi GCV in the outside world

While PCT builds the technology just like a "house", we pioneers build the house inside —

the furniture, electricity, decoration — making it livable and vibrant.

The Path Forward

I am so proud of all global pioneers —

You are awakening, working hard, and achieving significant progress.

Since OM, GCV has achieved its first success.

Now our mission is clear:

DeFi Features Launch:

DEX, AMM Liquidity Pools & Token Creation

On September 30, 2025, Pi Network officially deployed Decentralized Exchange (DEX) and Automated Market Maker (AMM) liquidity pool functionalities on its

These features allow developers and Pioneers to experiment with token swaps, liquidity pools, and other DeFi tools. Moreover, token creation is now enabled on Testnet — meaning users and organizations can mint test-tokens on the Pi blockchain, preparing for a full rollout on Mainnet later.

The focus: token utility, not speculation. Pi's documentation emphasises that tokens should support real applications and services, not just meme coins.

This milestone represents a leap in ecosystem functionality — moving from simple mining to tokenized assets and liquidity markets, readying for Web3 engagement.

App Studio Updates: Empowering Creators & Scaling Ecosystem Access

On October 16, 2025, Pi Network announced major updates to its Pi App Studio. ([Pi Network][2])

Key improvements include: Easier access via Pi Desktop navigation. * Expanded AI-assisted customization (e.g., AI logo generation, chatbot welcome messages)

Enhanced discovery interface for community apps, improved staking integration and app categorisation.

These enhancements lower the barrier for creators both technical and non-technical — enabling more Pioneers to build apps, integrate tokens and services, and participate in the ecosystem.

By combining app development, token issuance and DeFi features, Pi is creating a multidimensional platform where innovation, utility and community converge

3. KYC Breakthrough: Over 3.36 Million Pioneers Fully

On October 23, 2025, Pi Network reported that a new system-process upgrade using advanced AI and largescale datasets has allowed over 3.36 million "Tentative KYC" Pioneers to become fully KYC-verified.

The process analysed liveness checks and applications to ensure each applicant is a real, living person reinforcing Pi's "one person, one account" policy.

Of those fully verified, around 2.69 million have already migrated to the Mainnet blockchain.

Furthermore, another 3 million Tentative KYC cases are eligible for unlocking if they complete required liveness checks in the app.

This development is critical: it strengthens the network's integrity, ensures that the user base is real and verified, and builds the foundation for a trusted, large-scale Web3 economy.

What This Means for the Ecosystem

Integration of tokenization + creator-platform + verified identities forms a strategic trifecta:
* Tokenization & DeFi (DEX/AMM/Token creation): Allow

for real economic activity — minting, trading and liquidity. Creator Platform (App Studio): Enables Pioneers to build applications that use those tokens and DeFi

Verified Network (KYC): Ensures a genuine community base, reducing fraud and strengthening trust.

Together, these elements signal that Pi is no longer just a mining app — it is evolving into a full-stack Web3 ecosystem: a platform where value, community and utility converge

This is especially significant for the GCV (Global Consensus Value) movement, which seeks to establish 1 Pi = 314,159 USD as the community-defined benchmark. With token creation and DeFi features live, apps being built, and millions of verified users ready, the pathway to consensus value becomes far more credible.

Strategic Implications & Next Steps for Pioneers Pioneers should engage with the Testnet DEX/AMM features and explore token creation (within Testnet) to familiarise themselves with ecosystem mechanics.

App creators should utilise the new App Studio features, leverage AI tools, and develop services that tie tokens to real-world utility (not just speculative).

All Pioneers whose KYC status is "Tentative" should complete required liveness checks, ensuring they are eligible for full verification and Mainnet migration.

* Merchants and ecosystem builders should prepare to integrate Pi tokens and utility-tokens into their digital commerce models — aligning with the GCV value and community consensus.

The community should view these developments not as isolated updates but as building blocks of a larger vision: a decentralized, utility-driven, people-powered economy.

Conclusion

Pi Network's recent announcements represent more than incremental updates — they are milestones in its evolution from mining app to full-scale Web3 ecosystem. With token creation live, creator tools expanded and KYC barriers falling, Pi is laying the groundwork for utility, community and value—together.

For the GCV movement and for millions of Pioneers worldwide, the message is clear: the tools, infrastructure and verified community are now in place. The next step is adoption, application and consensus.




