Understanding the Strategy Behind Pi's "Welfare Period" and the Road to Global Expansion



movement, there comes a moment when clarity replaces confusion—when people finally see the strategy behind each step. Today, I want to speak directly to pioneers, the leaders, and believers who stand at the heart of the GCV era.

Doris Yin

Many people look at the current exchange prices and assume that what they see is the "true" value of Pi. But what they don't yet understand is this:

These prices are part of the welfare period.

Those who don't understand are simply watching from the outside.

Those who understand are already building the future.

Let me explain.

Exchanges Are Not Our Destination — They Are Our

Exchanges are not something to fear or argue about. They are vehicles designed to carry us toward our destination.

Think of exchanges as massive aircraft carriers – powerful platforms that can project influence across

I've noticed that many pioneers are complaining

In every historic about the perceived unfairness of exchange markets buying Pi at very low prices. This misunderstanding arises from their inability to see the bigger picture. Exchanges and ecosystems do not contradict each other; rather, they complement each other. Think of exchanges as representing the external aspect, while the ecosystem represents the internal aspect. If we consider this in terms of Yin and Yang, the exchange is like Yin and the ecosystem is like Yang. Both exist simultaneously and influence and support each other. There is no need to criticize exchanges or desire their removal; they are an integral part of our ecosystem.

Now compare it to mining Pi:

Mining is like your own small canoe — simple but enough to keep you afloat and move toward the destination. Early pioneers started early, mined more, and naturally hold more Pi. But the success of Pi Network requires billions of people holding Pi so that Pi can function as a true currency.

Someone who discovers Pi today would need years

But an aircraft carrier — the exchanges — allow newcomers to catch up by using this welfare period.

This is good for Pi Network development.

Some pioneers only see the Pi in their personal

But PCT is focused on how to make Pi successful on a global scale.

And the truth is simple:

If Pi does not succeed, your Pi has no value.

So we must support the vision of Pi Network — not only ourselves.

Today, the GCV community uses exchanges not as the final battleground, but as strategic tools for rapid global expansion. They give us visibility, presence, momentum... and access to billions of new believers.

But Pi's true value is not decided by exchanges —

It is determined by the pioneers, the ecosystem, and the GCV consensus.

Why This Is a Welfare Period

This early stage is intentionally designed as a welfare period.

Why?

Because we want to:

occupy more territory,

attract more believers and users,

pull in more developers, merchants, and innovators from every region.

The lower prices during this period have one purpose: Expansion. Accumulation. Preparation.

Those who understand use this moment wisely.

Those who don't... simply wait and wonder.

From the Inside Out: How We Influence Exchange Prices

The GCV Movement does not chase prices — it influences them.

Through community education, ecosystem protection, merchant adoption, and unified messaging, the GCV structure creates pressure from inside the ecosystem outward.

Eventually, this steady internal force pushes exchange prices toward balance.

Price always follows the rule of demand and supply. When the ecosystem operates under GCV, fewer people will sell Pi at \$0.20, \$1, \$2, or even \$100. They will prefer to use Pi at GCV inside the ecosystem.

As demand increases and supply tightens, the exchange price will naturally be pushed upward — long before the ecosystem reaches full maturity.

At that point, exchange prices will skyrocket toward GCV or close to it.

When the ecosystem matures: supply and demand align,

adoption grows,

reserves stabilize,

the exchange price will automatically converge with GCV consensus. And the need for reserves will gradually

This is not wishful thinking.

This is strategy.

Reserves Are Already Arranged

Yes, the transition requires large amounts of fiat liquidity.

And yes, those reserves have already been arranged. This ensures:

stability during expansion

cash-flow support for early merchants

a smooth transition from the welfare period to equilibrium

readiness for global circulation of Pi

Pioneers do not need to worry about the technical

Our role is collective strength, unity, and education. Your Contribution Matters: Invite, Educate, Unite

Right now, the most powerful action any pioneer can

Invite more pioneers into the GCV community.

Guide them.

Educate them.

Unite them.

Every invitation strengthens GCV.

Every new pioneer accelerates global adoption.

Every voice contributes to the future value of Pi.

This is leadership — and leadership belongs to all of

Please do not focus on the DEX activation date or the GCV activation date. While technical preparation is a necessary condition, it is not a sufficient condition. This means that the GCV activation represents groundbreaking news and must be handled with care; all conditions must be met. However, we are very close, and GCV has been confirmed. It's important to note that GCV activation is not our final goal; rather, it marks the beginning of a new journey.

We are no longer quessing

We are no longer waiting.

We are building.

Exchanges are tools.

GCV is the direction.

The pioneers are the power. And the future of Pi will be built by those who understand the strategy behind today's welfare period.

He added that bolstering cyber capacity across the Indo-Pacific, particularly among ASEAN nations, including the Philippines, remains a top priority.

US Embassy ICT unit chief Jennifer Schmidt said on the part of the US, Washington, DC continues to provide support in a range of areas from joint operations to policy, such as the development of the Philippines' cybersecurity plan.

"Cybercrime, it's a massive priority both for the Trump and Marcos administrations. So, our Federal Bureau of Investigation, our law enforcement, they roll up their sleeves and work side by side with the Philippine government on cybercrime operations," she said.

She also noted US-led multilateral initiatives to safeguard critical information infrastructure, including exploring open radio access network (Open RAN) technologies to reduce supplier dependency.

EU Ambassador to the Philippines Massimo

Santoro, meanwhile, said the EU is interested in helping the Philippines and the region maximize the use of artificial intelligence.

The envoy said the EU would raise the possibility of cooperation in the area during the inaugural Philippine-EU Security and Defense Dialogue in Brussels this month.

"It will not only be about artificial intelligence, it will be about the entire set of cooperation between the EU and the Philippines on cyber, maritime cooperation, and foreign information and manipulation interference," he said.

Australian Ambassador Marc Innes-Brown, meanwhile, cited Australia's ongoing cybersecurity work with key Filipino agencies, such as the Philippine Coast Guard.

He also disclosed that Manila and Canberra would identify more areas of cooperation in their inaugural bilateral cyber dialogue in Australia next month. (PNA)

Enforcement Division, DENR 4A, provided an indepth lecture on Presidential Decree 705 or the Revised Forestry Code of the Philippines and Republic Act 9147 or the Wildlife Resources Conservation and Protection Act, underscoring the need to safeguard forestlands and biodiversity.

This was followed by Mr. Reynaldo Cuerdo, Fishing Regulation Officer 1- BFAR 4A, who discussed Republic Act 8550 or the Philippine Fisheries Code of 1998, as amended by RA 10554. His lecture highlighted the regulations on sustainable fisheries management and the protection of marine resources.

Completing the day's sessions were Engr. Rea Mae L. De Austria, Research Specialist I, Mines and Geosciences Bureau (MGB) 4A, and Engr. John Borris R. Mampusti, Mining Claims

Examiner III - MGB 4A, who jointly discussed Republic Act 7942 or the Philippine Mining Act of 1995, focusing on responsible mining practices and regulatory enforcement.

On the second day, Ms. Josel Mae O. Amonelo, Environmental Management Specialist, Environmental Management Bureau (EMB) 4A, led the discussion on Republic Act 9003 or the Ecological Solid Waste Management Act of 2000, emphasizing proper waste segregation, disposal, and the roles of LGUs and enforcement operatives.


